







GRAND MASTER'S MESSAGE

KENTUCKY FREEMASONS PRODUCE DOCUMENTARY

In the early months of 2021, Brothers from Kentucky’s Lexington Lodge No. 1, William O. Ware Lodge of Research, and The Rubicon Masonic Society began to discuss the possibility of producing a visual record of Masonic dining. Later adding Masonic Restoration Foundation President Andrew Hammer to the group of producers, they partnered to script, cast, direct, film and edit a roughly 60-minute exploration of fraternal dining called, “The Masonic Table.”

“The Masonic Table” is intended to provide a visual outline for the organization and form of the Masonic feast in its most authentic setting – the symbolic lodge. Filmed at Lexington’s historic Spindletop Hall, production of the documentary brought together Brothers from at least six different Masonic jurisdictions to participate in the event.

W. B. Brian T. Evans, Jr., Past Master of Lexington Lodge No. 1 and Chairman of The Rubicon Masonic Society, added his talents as owner and operator of his production company, BT Media Productions, a division of BT Web Group, LLC. W. B. Evans wrote the final screenplay, served as Executive Producer for “The Masonic Table,” and was also Director and a leading cast member.

Careful preparation went into refining the plans for the documentary, writing a script, storyboarding the event, securing and scouting a location for filming, and identifying potential members of the cast. Equally important was the necessity of securing the funds needed for production. The announcement of the plans for the documentary created a great deal of enthusiasm, and generous donations from lodges and individual Masons came quickly. Producer/Director Evans shared his thoughts about being involved in what appears to be a ground-breaking approach to the topic of Masonic feasting, “*Freemasonry is the oldest and most honorable fraternity in the world, yet membership is declining. Much of the public is unaware of its existence, and even members are largely unaware of its landmark traditions, such as this. Through this documentary, we hope to educate viewers more about Freemasonry by demonstrating the pleasing elegance of fraternal bonding, as Brothers near and far gather together outside of the Masonic lodge for a memorable dining event.*”

W. B. Hammer, along with W. B. John W. Bizzack, carefully developed the “Form and Order” for the evening that incorporated many of the historical elements of Masonic dining. The traditional toasts were included, along with songs that were seamlessly woven into the pageantry of the evening. W. B. Hammer described the essence of the message of “The Masonic Table” as follows, “*The Masonic harmony, or festive board, has in recent years become one of the most sorely neglected components of Masonic lodges in America. Yet it has always been with us, and should be fully revived. Our aspiration with this documentary is to show the reason why.*”

On the eve of production, W. B. Evans and his production team moved their equipment into Spindletop Hall. After performing lighting and sound checks, all was in readiness for action. For W. B. Evans and his crew, the day of the event began at 7:00 A. M. and ended well after midnight. Commenting on the challenges of completing the filming in a single day, W. B. Evans said, “*To creatively capture this documentary within three acts, forty-six scenes, and up to four takes per scene within one day of filming left no room for error. It required a tremendous amount of pre-production planning by the producers and the crew, as well as extraordinary patience and resolve by the 34 participating Brothers in the cast.*”

Interspersed throughout the documentary are portions of interviews with several Brothers who offered their views on the importance of Masonic dining, their experiences with respect to Masonic toasts, their favorite elements of Masonic feasting, and the meaning that the act of gathering around the Masonic table brings to them.

W. B. Hammer added his views about how the documentary enhances an understanding of Masonic dining. W. B. Hammer stated, “*There are many lodges that would like to add the kind of ceremonial dining one finds at a harmony to their evenings, but don’t have a way to visualize what that might look like in practice. This allows brethren to do that, in a way that respects the privacy of the event, while providing an historic context for the hows and whys.*”

Although physically and mentally exhausted after the filming, the Brothers who participated in the cast were excited about being a part of this historic contribution to the store of Masonic education. W. B. Bizzack added, “*As we note in the film, what we do is what works for us, and in no way do we suggest that this is the only way to create the Masonic table experience. The commitment that we saw during the 18 hours of filming is a testament to each of the men attending, and speaks to their wish to offer the experience to all others who may seek the same.*”

Whether seen as an overview of the history of Masonic dining, or viewed as providing guidance for the execution of such an event in its original context – the local symbolic lodge – “The Masonic Table” is another vehicle for assembling men under the banner of Masonic brotherhood. “The Masonic Table” seeks to enhance and advance the spirit of Freemasonry.

The production of “The Masonic Table” illustrates the capabilities and resourcefulness of Kentucky Freemasonry. It is undoubtedly a unique offering to the Craft at large, and one of which Kentucky Freemasons may be justifiably proud.



CORRECTION!!!



"I Didn't Know That....."

With the 300th Anniversary of Anderson's Constitutions of 1723 rapidly approaching, it is almost certain that Masonic scholars will be reviewing its impact upon the world. It was the first Masonic book printed in America in 1734. The printer was non-other than Brother Ben Franklin. Many of the principles contained within these Constitutions would later be included in the Constitution of United States and the Bill of Rights. We can leave the investigation of this correlation to the scholars to review. However, Dr. Patrick Mendez (John Hopkins University) outlines these principles in his book *"Commercial Providence: The Secret Destiny of the American Empire"* (MHJ 11/2021 issue).

The Regius Poem or Halliwell Manuscript was discovered in the British museum in 1848 by James Halliwell. Authorities have dated it 1390. Written in verse, it is believed to be the oldest of the Constitutions or "Old Charges" of Freemasons. Because of the 14th century Chaucer English, it is most difficult for the man in the street to read. Fortunately for curious Mason, the Regius Poem can be found 'deciphered' on the internet. Since the late 14th century to present, well over 100 copies of these manuscripts have been discovered. The Grand Lodge of Kentucky's 1808 "Masonic Constitutions or Illustrations of Masonry" contains an abbreviated form of the 'Old Charges' as edited by Anderson. Examining the Day vs Night versions by laying Anderson's Constitution next to one of the Old Constitutions is an exercise in the difference between operative and speculative masonry.

Perhaps it is time to look the first known Masonic book ever published, *"The Old Constitutions belonging to the Ancient and Honourable Society of Free and Accepted Masons"* published in London by J. Roberts in 1722, about one year before Anderson's Constitutions. Only two copies are believed to exist making it the most valuable of all Masonic books. The cover purports it to be "Taken from a Manuscript wrote about 500 Years Since" which is no doubt overstated. Definitely one of the old operative manuscripts, however it is the 1663 'Additional Orders and Constitutions' included in the book which appear to be most relevant. The additional "orders" demonstrate needed adjustments to compensate the rise in non-operative membership.

They are as follows:

Additional Orders and Constitutions made and agreed upon at a General Assembly held at -----, on the Eighth Day of December, 1663.

I. THAT no Person, of what Degree soever, be accepted a Free-Mason, unless he shall have a Lodge of five Free-Masons at the least, whereof one to be a Master or Warden of that Limit or Division where such Lodge shall be kept, and another to be a Workman of the Trade of Free-Masonry.

II. That no Person hereafter shall be accepted a Free-Mason, but such as are of able Body, honest Parentage, good Reputation, and Observers of the Laws of the Land.

III. That no Person hereafter, which shall be accepted a Free-Mason, shall he admitted into any Lodge, or Assembly, until he hath brought a Certificate of the Time and Place of his Acceptation, from the Lodge that accepted him, unto the Master of that Limit and Division, where such Lodge was kept, which said Master shall enroll the same on Parchment in a Roll to be kept for that Purpose, and give an Account of all such Acceptations, at every General Assembly.

IV. That every Person, who is now a Free-Mason, shall bring to the Master a Note of the Time of his Acceptation, to the end the same may be enrolled in such Priority of Place, as the Person deserves, and to the end the whole Company and Fellows may the better know each other.

V. That for the future the said Society, Company and Fraternity of Free-Masons, shall be regulated and governed by one Master, and as many Wardens as the said Company shall think fit to chuse at every Yearly General Assembly.

VI. That no Person shall be accepted a Free-Mason, unless he be One and Twenty Years Old, or more.

VII. That no person hereafter be accepted a Free-Mason, or know the Secrets of the said Society, until he shall have first taken the Oath of Secrecy here following, viz.

IA. B. do here in the Presence of God Almighty, and of my Fellows and Brethren here present, promise and declare, That I will not at any Time hereafter by any or Circumstance whatsoever

directly or indirectly, publish, discover, reveal or make known any of these Secrets, Privities or Councils of the Fraternity or Fellowship of Free Masons, which at this time, or at any time hereafter shall be made known unto me. So help me God, and the true and holy Contents of this Book.


This new additions no doubt relate to the heavy influx of "accepted" Masons into the operative fraternity. #1 requires at least one member be a workman of the trade. Apprenticeship usually began at about 14 years of age becoming a fellow-of-the-craft at about 21 years. It would seem that item VI's age requirement of 21 years fits those 'accepted', but not tradesmen who were usually apprenticed at age 14, becoming a 'fellow of the craft' about seven years after.

In 1661, Parliament began a series of acts which became known as the 'Act of Uniformity of 1662', requiring clergymen to take an oath to the king, to make compulsory the use of Anglican Book of Common Prayer and not attend unlawful assemblies. Over 2,000 clergymen refused to take the oath and were expelled from the Church of England. In addition, Quakers, who by religious conviction, did not believe in oaths, were fined, and repeat offenders were imprisoned with hard labor for three to six months. Other restrictive Acts of Parliament would follow. Fear of being considered 'non-conformists' and of what Acts may follow, possibly fueled the decision of the fraternity to add the 1663 additional orders, and explain who these Accepted masons were and that their meetings were harmless to both Parliament and the Anglican Church. 



GATEWAY LODGE #109 EVENTS SUPPORT CHARITIES, PROMOTE BROTHERHOOD


