

I stand before you today honored and Proud to have been elected to serve as your Grand Master. I thank everyone of you for your part in making this happen. I am committed, to you, to fulfill my duties and obligations to the best of my skill, abilities and with a humble heart.

When I think of the line of truly great men that I have followed, I am deeply inspired. They have made so many personal sacrifices and worked diligently to lead our fraternity, I can only hope that my own efforts to this cause will reach the high level of the bar they have set

Several years ago, when I was asked what my motto would be if I was to serve as Grand Master, I gave it great thought. The one recuring belief that I thought would send the message I wish to convey is "We are our Brother's Keeper" This is a remarkably simple phrase

but carries much weight. It reminds us of our commitment to our brothers, from the newly initiated Enter Apprentices to our Most Senior Master Masons, to the destitute or distressed, widowed or the widower. My Programs focus on Masonic Youth Groups, Preparedness, the Book of Constitution, and basic lodge education in hopes of ensuring a strong foundation for the future of Kentucky Freemasonry.

I am committed to supporting the young men and young ladies of the three masonic youth groups, as they are our future leaders, in this fraternity and in our communities. With the support of the leaders of the Kentucky chapters of DeMolay, Rainbow and Jobs Daughters I have established a new committee, the "Masonic Youth Group Support "committee. This committee is comprised of brothers who are knowledgeable and experience with these youth groups. They will work with My District Deputy Grand Masters to provide information and support to Kentucky Lodges

Masonicare Continues the Legacy of Fraternal Care and Support

Established in 1867 following the Civil War, Masonic Homes Kentucky fulfills the vision of Kentucky Masons to create a way to care for senior Masons and their families. Today, one of the ways Masonic continues this mission is through Masonicare, a charitable care and housing program for Masons, their wives or widows when they are no longer able to care for themselves.

On average, Masonic serves 20-25 Masonicare residents per year. Masonic spends more than \$205 per day on each Masonicare resident, or \$1.5 million annually, to provide the care they need and deserve. Along with quality care and housing, as well as general living necessities like wheelchairs, glasses, transportation, meals, clothing and more.

We currently have 61 widows/wives and 38 Brothers who are residing at one of our three Masonic campuses. We currently have 18 widows and brothers receiving Masonicare benefits, they include:

To meet minimum eligibility requirements, a prospective Masonicare resident must be:

- a Master Mason in good standing with a Kentucky Masonic Lodge for five consecutive years;
- or, the wife of a Master Mason who meets the above eligibility requirements;
- or, the widow of a Master Mason (who met the above eligibility requirements prior to death) who was married for at least five years and has not remarried;
- and, be at least 60 years old.

Masonic will also complete a 5-year financial review of anyone applying for Masonicare.

or individual masons in an effort to encourage communication, support, and growth of these youth groups. I encourage anyone who wants to be an adviser to contact this committee and see how you can help.

I have commissioned a special lapel pin to sell, the proceeds of which will be donated to the three masonic youth groups. The lapel pin depicts a taco with the phrase "Taco's for kids" on it. I had 500 made and I will be the only one selling these pins. The cost is \$20 each.

I have renewed the Committee of Emergency planning; I had been discussing this with M.W. Gary Rose PGM prior to his death. The Tornados that struck in Western Kentucky and the flooding in eastern Kentucky have impacted so many lives, these tragedies confirmed my belief that we need to be better prepared to protect our members and assist the community. I selected W.B. Drew Chandler PM #41, Head of the Woodford County Emergency Management to serve as Chairman of this committee, with the mission of providing lodges with information and tools

to eliminate hazards in and around the lodge buildings, and to prepare for emergencies and ultimately lend a hand in our communities.

The Education Committee will be focusing on the Book of Constitution, lodge officer's duties and important lodge functions. During my time in the Grand line, I have noticed that many of the problems that lodge officers face is due to lack of knowledge of their responsibilities and requirements laid out in the Book of constitutions..

In hopes for us to lift up the legacy of those who have gone before us in the Kentucky Masonic tradition, I have created a new committee called the Historic Preservation committee. It shall be the duty of this committee to coordinate with the various subordinate lodges to procure, edit, and proof a historical sketch of each respective lodge. They shall utilize the compilation of historical sketches collected by Past Grand Master James N. Saunders as a basis for their work. The end goal of this committee is to publish a multivolume set of the histories of the subordinate lodges, as well as a compilation of biographies of the Past Grand Masters, in conjunction with the 225th Anniversary of the Grand Lodge of Kentucky, F. & A.M.

A Tilers Sword will serve as my Grand Master's Statewide Traveling Program. The Tilers sword enables him effectually to guard against the approach of cowans and eavesdroppers, and suffer none to pass but such as are duly qualified, so it should morally serve as a constant admonition to us, to set a guard at the entrance of our thoughts; to place a watch at the door of our lips; to post a sentinel at the avenue of our actions, thereby excluding every unqualified and unworthy thoughts word, and deed; and preserving consciences void of offense toward God and toward man. The objective this Program is to promote travel across the state and to support the Grand Lodge Scholarship fund.

I want to thank M.W. Geary F. Laird PGM, M.W. Tim Sanders PGM, M.W. Chris Stout PGM and M.W. Ernest Jackson PGM for a spectacular installation. Your leadership, brotherly love and friendship have been an inspiration to me, and I hope that I can

continue the example you have set. Each of you have supported and mentored me during my time in the Line and It was an honor to have such great Masons, my "Big Brothers" perform this ceremony.



As I close, I remind you all that "We Are Our Brother's Keeper."



MASONIC LIBRARY AND MUSEUM ASSOCIATION COVINGTON SCOTTISH RITE "I Didn't Know That....."

The Grand Lodge of Ohio has recommended to their Craft, "7 Books to Read This Winter". The books are perfect for both Masons, and non-Masons. There are plenty of Kentucky Masons who love a 'good read' especially during the winter months. Sitting in a soft chair with a book in hand is a perfect combination on a cold night. Even if you have previously read some of these selections, it is certainly good to refresh your Masonic history and knowledge. (Hint, hint - Ladies, Christmas is coming!).

Let's take a look at their suggestions!! This is an excellent list. All are fine reading and packed with a lot of information. Full reviews are available for some of the mentioned books by noted Kentucky Masons on the William O. Ware Lodge of Research web page. You too, may have your favorite 'winter reads' and if so, drop me a line and tell me about your thoughts.

The first book on the Grand Lodge of Ohio's list is "American Freemasons: Three Centuries of Building Communities" authored by Mark A. Tabbert. W.B. Tabbert is currently the Director of the Library and Museum Collections of the George Washington National Masonic Museum and is a well-respected Masonic author, lecturer and a member of Quatuor Coronati Research Lodge.

This beautifully illustrated and well researched book was printed in 2005, and contains America's development from the Revolution, through the Civil War and into the 21st century, and the Masonic influence therein. It is thoroughly reviewed by Kentucky Mason W.B. Dan Kemble on the Wm O. Ware web page (Book Reviews-May 2019). If you like this book, you will absolutely love Brother Tabbert's newest, "A Deserving Brother: George Washington and Freemasonry", as well as the accompanying books "Almanac of Freemasonry Volumes 1 and 2".

"A Pilgrim's Path", written in 1993, is the last of three books written by author John J. Robinson. His first and most popular book "Born in Blood: The Lost Secrets of Freemasonry" was written while living in Northern Kentucky, and revived a new interest with-in and with-out the Fraternity. Robinson is also known as the "founding visionary" of the Masonic Information Center. "A Pilgrim's Path" written just shortly before John Robinson became a Mason, is well-researched, and destroys many of the false accusations against the fraternity. This book, along with the Masonic Information Center has done much to expose and slow down the anti-Masonic movement. This should be a 'must read' by every Mason. Still a very popular book, it is in detail, reviewed by W.B. Dan Kemble on the Wm O. Ware Lodge website (Book Reviews-December 2021).

"The Better Angels of Our Nature: Freemasonry in the American Civil War" (2012) by award winning Masonic author Michael A. Halleran is a perfect book for Civil War enthusiasts. The book dispels often repeated wartime Masonic myths and allows new information. It deals largely with the bravery displayed, as well as the "friendship, morality and brotherly love" that actually existed between the two sides. It is a pleasure to read. Again, an excellent, Chapter by Chapter review, written by W.B. Ryan A. Clendenen can be found on the same website (Book Reviews-April 2022).

Written in 1975, "The Craft and its Symbols" is an ideal presentation















by prolific author, W.B. Allen E. Roberts, for the newly made Mason (old-timers too). It allows one to begin to understand the symbolism contained in the symbolic degrees. In it is compiled the very basics to understanding the first three degrees in symbolism, allegory, and purpose. This is something every Mason *should* know. Allen Roberts has always presented quality reading material, and this is no exception.

"The Craft: How the Freemasons Made the Modern World" by well-known historian (University of London) John Dickie, is a detailed and well researched history of freemasonry, its culture, theology, and politics. His style of storytelling on each of the many subjects creates a very enjoyable read. Dickie has no problem identifying what he considers freemasonry's successes and its failures in history. It is meticulously reviewed by W.B. John Bizzack on the Wm O. Ware Lodge website (Book reviews-September 2020).


"Freemasons for Dummies" is not only a 'crash course' in Freemasonry, it is a fun read. Author W.B. Christopher Hodapp leaves 'no stone unturned' as he answers questions on everything freemasonic. It is an outstanding book for all Masons and non-Masons alike and should be a mandatory read for every new member of the Craft. This is a highly popular book first published in 2005, recently reprinted and is available as an audio book. It is particularly recommended to those who want quick and easy explanations on a large variety of Masonic subjects. Brother Hodapp does just that.

"Freemasonry: A Very Short Introduction" is a 5 X 7 book of 140 pages that is small but jam-packed with information. It was authored by Dr. Andreas Onnerfors, Professor of Intellectual History (Erfurt, Germany) for the Oxford University Press, in 2017. The "Very Short Introduction" series, boasts hundreds of books on everything from "Accounting" to "Zionism". This scholarly book contains very little of the American Freemasonic experience, but lends itself to more of an international flavor. Still it covers an in-depth overview of Freemasonry, including: myths, conspiracies, history, rituals, and symbols, and presents them as an exciting read.

All the books mentioned are both entertaining and well researched. They can easily be picked-up to read a portion as time allows and then put down, to be picked up again. Two of the books have a more scholarly appeal. Andreas Onnerous and John Dickie are just two of a large number of professors now investigating and writing about Freemasonry. How fortunate for the Masons of today that so many of academic rank are taking a look at Freemasonry. The 21st Century may well be the best 100 years Freemasonry has ever had!!

Soldiers were first assigned to guard the Tomb of the Unknown Soldier in 1926, to discourage visitors from climbing or stepping on it. In 1937, the guards became a 24/7 presence, standing watch over the Unknown Soldier at all times since that date.




