SHADY GROVE NO. 559 FOUR GENERATIONS

It is often said that Freemasonry runs in cycles. Up one decade and down the next in a flowing trend. It is also said that Masonry tends to skip between generations. There is a lodge in Shady Grove, Ky. Where James E. Sherrill Sr., and all four of his sons are Past Masters. It all started with a young Jimmy going for back surgery at Kosairs Hospital in Louisville, Ky. His family lived in Western Ky. and did not have the means to go for visits. So James had to endure long days and even longer nights feeling as alone as possible. He spent most of his time looking forward to Sundays... for that was when Mr. Hobby would visit. Mr. Hobby was a local Shriner that would visit the children and made them feel like he was there just to visit them. Mr. Hobby was a jolly man that always had a smile, piece of candy or a balloon animal for the kids. He always wore his Fez while visiting the kids and young Jimmy once asked him if he could get one of them one day. Mr. Hobby simply smiled and said, "That you never know."

James eventually grew to manhood and moved back to Western Ky., where he finally got up the nerve to ask a friend named Carl Cornish for a petition. Brother Carl is a member of Parkersville Lodge #580, and is still a good family friend, as well as Masonic Brother. James was initiated on 6-21-75, passed on 7-19-75, and raised 8-16-75. James had four sons, each of them joining as they came of age. Jesse L. Sherrill was initiated on 8-15-87, passed on 9-19-87, and raised on 10-23-87. Jesse had noticed the ring our Dad always wore and wanted to know more about what it stood for. James E. Sherrill Jr. was initiated on 5-20-89, passed on 8-19-89, and raised on 9-2-89. For J.J. it was a keen desire to emulate his father that caused him to seek the light. I. R. Steven Sherrill was initiated on 4-18-92, passed on 5-16-92 and raised on 6-20-92. For me, it was always my curiosity about the significance of the Ky. Monitor that dad always kept on the mantel. Daniel R. Sherrill was initiated on 3-15-97, passed on 11-22-97, and raised on 12-20-97. Danny always wanted to know what Dad did with this group of men he would meet with every month. All five of us have served terms in the East, usually for multiple years. Dad finally got his wish to become a Shriner in the early eighties, and went on to see three of his four sons make the long trek as Weary Sons of the Desert in the last 2 years. Each and every one of us is proud of the differences that Masonry has made in our lives and will always cherish the special connection that we have with our Dad. Our Lodge may not be the biggest or the richest, but we are full of Masonic Spirit. This is just one example of how Masonry can affect one family, and to a greater extent how it can affect our greater Masonic family that we all belong. We are all proud to be Masons, and look forward to our sons joining in the due course of time. My 10-year old son Alex has already asked me if I thought he would be good enough to join one day. I simply smiled and said, "You never know, do you son"? So Mote It Be!

FROM YOUR GRAND SECRETARY

"We've got to change". "Masonry has to change". "We're stuck in the past". "The older members of the lodge resist change". No doubt we have all heard these remarks regarding Freemasonry at one time or another. What we may fail to realize at the time is that we have changed over time, slowly perhaps - but changed nevertheless. Certainly, the principles and tenets of the Craft have not changed because they are unchangeable: however our modern day approach to the Fraternity, and the way we practice our Craft, has slowly changed from the way we approached and practiced it a century or so ago. Today we do not meet by a moon schedule, though a few lodges still do so. We no longer travel to lodge by horseback, though we do arrive via horsepower. We no longer struggle to see by moonlight, candle power, or gaslight - but by a constant light source, measured by candlepower (expressed in lumens) supplied by electric current. We no longer have to experience the uneven heat of a coal or wood burning stove to break the chill of the cold of winter, or the opening of vents and windows to get relief from the summer heat - but have the option of central heating and cooling technology to provide us with a comfortable environment during our lodge Communications.

So, considering the above facts, it becomes quite obvious that the Fraternity has succumbed ever so slowly to change over time. The fact it does change is a natural phenomenon since the world, and nature, does not exist in a static state - but in a dynamic state. One of the basic laws of dynamics (kinetics) is that an object in motion tends to remain in motion until influenced by some outside force. So it is with our Fraternity. The principles of Freemasonry remain in constant motion, the same as they were in the beginning; however, our approach to the practice of the Craft has been influenced by the slow change of society and the expansion of technology. So it becomes quite obvious, considering all the advantages available to us in these modern times, that all change is not a thing to fear, and that Freemasonry has done a reasonable job meeting the challenges of changes in our society, while holding steady to the unchangeable tenets of the Fraternity.

Therefore, it appears, to me at least, that it's not change in its self that draws resistance from the membership - but it's the pace and rate of drastic "change" over a short period of time. Slow change appears to come from slow and deliberate consideration of the need for a change, one seen as necessary to address a situation that presents, or may present, a problem for the Fraternity. Many times a drastic, or quick, change seems to be directed more to the symptoms of a problem instead of to the root of the problem, and is done in such haste as to not consider what ramifications the changes may have in the Fraternity as a whole. The old saying: "Act in haste, repent in leisure" comes to mind.

So, I think it's most important that we recognize, and keep in mind, the distinction between those changes that occur quite naturally in the Fraternity, and those that are sometimes suggested, in many cases, to address one issue only. To do otherwise may not demonstrate the best example of good stewardship.

By this article, I certainly don't mean to suggest that I have the answers to all the challenges facing the Fraternity at the present time - but I do hope that I have

given you at least a little something to think about. Each one of us, from the Grand Master to the youngest Entered Apprentice, is solely responsible for the health and welfare of our Fraternity during the time it is under our stewardship. Let's make sure that we pass it along to the next generation in at least as good a shape - but, hopefully, better - than when we received it.

IT ALL DEPENDS ON US!

NOTICE

Section 217 of the Book of Constitutions requires that all motions on resolutions pertaining to amendments of the Constitutions or Laws of the Grand Lodge shall be submitted in writing and presented to the Office of the Grand Secretary no later than August 15, prior to the Annual Communications.

NOTICE

Section 12 (3) of the Book of Constitutions requires that an Elective Representative be a Permanent Member chosen by ballot from the members of his lodge, to represent it in case its Master, Wardens or Secretary cannot attend the communication of the Grand Lodge, and such representative shall be given a certificate of his election over the lodge seal.

WAIVER OF JURISDICTION- FEES RETURNED

Most recently there have been several inquiries made to the Grand Lodge Office concerning the return of fees when a waiver of jurisdiction is granted by a Lodge which has a higher initiation fee than the Lodge making the request for the waiver of jurisdiction.

Section 98(a) of the Book of Constitutions of the Grand Lodge of Kentucky, F&AM deals specifically to this matter and states:

"In all cases where the fee of the Lodge granting the waiver of jurisdiction is greater than the fee of the Lodge requesting the waiver the candidate shall pay to the Lodge which asks the waiver a fee equivalent to the fee he would have been required to pay had he petitioned the Lodge which granted the waiver. Immediately after the candidate is elected and initiated, the Secretary of the Lodge receiving the waiver shall send the difference in fees to the Lodge granting the waiver."

Simply put, when a Lodge receives a waiver of jurisdiction in favor of a candidate from a Lodge having jurisdiction, where the initiation fee of the Lodge granting jurisdiction is higher than the initiation fee of the Lodge that is requesting the waiver, the candidate pays the higher fee and the difference in the fees must be paid to the Lodge granting the waiver.

ANNUAL RETURNS

Before the end of May you should have received a packet from the Grand Lodge Office containing:

- 1. A form asking for information on members you may have in the Masonic Homes of Kentucky.**
- 2. A form certifying the representative of your lodge at our Grand Communication in October (in case the Master or one of the line Officers can not attend).**
- 3. A post card for you to complete and return to this office.**
- 4. Instruction sheet for checking Annual Returns.**

I urge you to take care of this quickly, to assure adequate time to review and record the results before Grand Lodge.

Also, sometime in the latter part of July, you will receive a computer printout of your membership and the lodge's Annual Return. Please check this information very carefully for accuracy and return the Annual Return to the Grand Lodge as quickly as possible. *It is not necessary to send the Annual Return and payment for the assessments to Grand Lodge at the same time.* As soon as the Annual Return is received (after you have checked and corrected it, if necessary) we can then assemble the information in ample time to have it available to the membership at Grand Lodge. You may forward your check for assessments prior to September 1, deadline. *It is very important the June Monthly Activity Report be received in the Grand Lodge Office as soon as practical after the end of the month-before the tenth of July deadline, if possible.*

The Office Staff hopes to have the yearly statistical information of each lodge entered into the computer and the Annual Returns completed by the last week in July. I know I can depend on the continued cooperation of the dedicated lodge secretaries of this Grand Jurisdiction to do their best to preserve and maintain a complete and accurate record of their lodge activities.

NOTICE OF REJECTION

Just a reminder to each lodge secretary to report to the Grand Lodge Office, on the proper form, any petitioner for the degrees who has been rejected by your lodge. I am not sure all lodge secretaries are aware they should report this activity. However, this information could be valuable to another lodge, should the one rejected attempt to petition another lodge at a later date.

In case you do not have any of the Notice of Rejection Forms, you may order them from the Office of the Grand Secretary.

OFFICIAL OUT-OF-STATE CORRESPONDENCE

Just a reminder, all official correspondence between Grand Jurisdictions must be transmitted through the Grand Lodge Office. This includes all request for demits, reinstatements, transfers, affiliation, waivers etc. Consequently, if you correspond directly with a Lodge in another jurisdiction on any of the above mentioned transactions, they will be delayed until such time as the proper Masonic protocol is established.

However, a member of a Lodge of a sister jurisdiction, even though he may now reside within the jurisdiction of the Grand Lodge of Kentucky, is at liberty to correspond directly with his Lodge.

So, please remember to observe proper Masonic protocol in dealing with all official out-of-state transactions and/or correspondence.

INDEPENDENCE DAY

The Grand Lodge office will be closed Friday, July 4, 2008 to observe Independence Day.

BATTLE OF RICHMOND MASONIC MEMORIAL DEDICATED



On Saturday, May 10th, over 75 Masons and members of the Order of The Eastern Star dedicated the Battle of Richmond Masonic Memorial on the grounds of the Battle of Richmond Visitors and History Center in Richmond, Kentucky.

The 8 ft. gray granite memorial, featuring the square and compasses, was dedicated by Richmond Lodge No. 25, Madison (Kirksville) Lodge No. 183, Kingston Lodge No. 317, Waco Lodge No. 338, and Berea Lodge No. 617, along with the Richmond Chapter No. 438, Order of the Eastern Star. The monument honors members of the Masonic Fraternity, both Union and Confederate, who fought at the Battle of Richmond on August 29 & 30, 1862.

Past Grand Master Robert Davenport gave the keynote address, with comments also from Past Grand Master Gregory Powell. Myra Searcy represented the Grand Chapter. Brother George Pennington, Master of Kingston No. 317 and past District Deputy, served as Master of Ceremonies.

The memorial is thought to be only second of its type on any Civil War battlefield. The Grand Lodge of Pennsylvania dedicated the Masonic Friend to Friend Monument at Gettysburg in 1993.



But my story isn't about facts and figures; it's about *Daddy*, as Al is called by his daughter, Gerry Roberts.

When I met Al and Gerry, she shared how they chose the Masonic Home as Al's new home, and how Al transitioned from an apartment to the Personal Care Center, then to the Health Care Center neighborhood where he now lives.

Al and Gerry made me realize that the Homes do not care for *patients* or operate a *nursing home*. We are caring for *Daddy*, someone's beloved family member who relies on us for daily care.

She told about her cancer diagnosis a few years ago. Her doctor advised against visiting Daddy while taking chemotherapy to protect her immune system. Gerry was used to visiting Daddy every day—she was beside herself at the thought of not seeing him for three months. In tears, Gerry advised Personal Care Director Kim Sublett of her diagnosis and the treatments that would prevent her from visiting Daddy.

Together, Gerry and Kim broke the news to Al. As Gerry prepared to leave, Kim gave her a hug and whispered, "Go take care of yourself, we'll take care of Daddy." And, we did. Gerry fully recovered and Al has marked another milestone birthday.

COVINGTON LODGE No. 109 HONORS 60 YEAR MEMBER



Covington Lodge 109 was proud to honor Robert L. "Bob" Williams in 2007 by presenting him with his 60 year service award as a Kentucky Mason. While 60 years of Masonry in itself is a worthy accomplishment, it is only part of the story of Bob Williams.

Bob Williams is a proud veteran of World War II. During the war, Bob became an original member of the newly formed 506 Parachute Infantry Regiment of the 101st Airborne Division "The Screaming Eagles". Bob made the combat parachute drop into Normandy, France as part of the airborne landings for the D-Day invasion of Europe in June 1944.

Bob boarded a C-47 cargo plane at 10:00 PM on June 5, 1944, for the invasion. When they reached the French coast they started receiving enemy anti-aircraft fire. Bob's first combat experience occurred as he looked out the door of his plane, he watched as the plane flying next to his exploded before his eyes killing 21 men. At 1:30 AM, Bob parachuted into Nazi occupied France near the tiny village of Foucarville, Normandy, France. In the darkness, Bob linked up with three other American Airborne Troops. A short time later they ran into a German machine gun nest. Two of the men with Bob were killed instantly. Bob received twelve bullet holes on his left pants pocket but amazingly was not wounded during the encounter. What followed after that first night was weeks of intense fighting in and around the French town of Carentan by Airborne forces. Bob somehow managed to survive and was not wounded during the intense combat in France. However, Bob's best friend Joe Slosarczyk lost his life just nine days after the battle started.

Bob eventually returned to England. Bob witnessed the terrible bombing of London by German V-2 rockets. Bob returned home and was discharged from the Army in December 1945.

Bob returned home like many veterans and put the war behind him. He got a job as a diamond setter for a jewelry manufacturing company. Bob was raised as a Master Mason on April 6th, 1946. Like many others of the "greatest generation" he returned home to build a peaceful life for himself. He raised three kids, managed a farm and eventually retired as a jeweler. Bob never thought of returning to France, having the usual combat soldier's guilt for having survived the war, preferring to forget everything that happened.

As the years passed, and the fiftieth anniversary of D-Day approached, his feeling on the war

changed, and Bob did want to return. Not just to visit, but to jump again, a re-enactment if possible from a C-47 as a memorial to those who died in the invasion. Bob felt that the a 50th anniversary jump would be a wonderful thing to do in memory of those that did not survive to live fifty more years, to experience life and raise a family, as Bob had done. Bob felt it would be a way to let family members know that their loved ones were not forgotten, and remind the rest of the world, especially the younger generation, to know the sacrifices that were made fifty years ago for their freedom.

Bob along with other World War II airborne veterans from around the world formed the Return to Normandy Association. The group would focus on planning a parachute jump on June 5th, 1994 to celebrate the fifth anniversary of the D-Day. D-day airborne operations began when airborne troops called Pathfinders actually began to jumping prior to midnight on June 5th, 1944, while history records D-day as June 6th, 1944.

To say the group had a struggle to actually do the 50th anniversary jump is an understatement. It took a year and a half to finally get the Department of Defense, and the governments of the United States and France to agree to let the veterans jump. It seemed that no one wanted to be responsible for a group of 70+ year old veterans jumping out of planes while in front of worldwide media. Only upon a decision from the president of the United States and the French government was the Return to Normandy Association allowed to participate in the 50th Anniversary celebration. The U.S. Military and the French Government would allow Bob and the others to jump, but the group would have to find their own parachute equipment, find a vintage C-47 cargo plane that could be flown to France, and the group would have to train and be re-certified to make parachute jumps with modern chutes. This all seemed like an impossible task. The amazing details on how these things were accomplished and more of Bob's experiences from the war are written in a book by him titled Return to Normandy.

On the 50th Anniversary of the start of the D-Day Invasion, Bob Williams at age 71 and 25 other men jumped out of a C-47 cargo plane into Sainte-Mere-Eglise in Normandy, France. The group broke the world record for the oldest average age to jump from a single plane at 72.13 years with a combined total age of 1875 years.

When Bob jumped out of the plane that day he carried a picture of Joe Slosarczyk in his left breast pocket to remember his friend and the other fallen comrades of D-Day. After Bob landed he was walking alone in an open field with parachutes in the background and a proud smile on his face. Unknown to Bob, a world famous Time Life photographer named David Burnett took his picture. The picture appeared as a centerfold in TIME on June 20th, 1994 and several times since 1994. A similar picture taken by a French photographer appeared on the front page of the New York Times and many others on June 6, 1994. Bob calls the David Burnett picture "My Field of Dreams".

Since the jump in 1994, he has remained very active. In June of 2000, Bob participated in the dedication of author Steven Ambrose's D-day Museum in New Orleans. He was on the set as an advisor for the 2001 HBO series Band of Brothers by Tom Hanks and Steven Spielberg. He worked as the county campaign chairman for a Northern Kentucky Congressman. He has put together a

World War II museum at his home. He visits high schools and elementary schools speaking to young people about World War II. He was recently interviewed and appeared in a KET special about Kentucky veterans of World War II. He still manufactures and sets jewelry in his spare time.

In November 2007, Covington Lodge 109 was highly honored to have Time-Life photojournalist David Burnett donate a signed print of his picture of Bob after jumping into Normandy in 1994. It was dedicated by Bob Williams to be permanently displayed in the Scottish Rite Temple in Covington, Kentucky. Bob humbly said that the photograph should be dedicated to everyone who fought in World War II.

The brothers of Covington 109 feel that Bob Williams represents the highest ideals of Masonry for his service, sacrifice, brotherhood, and a dedication to his fellow man. Bob is a man who puts Masonic ideals into real world actions.


