*To the Officers and Brethren of the Most Worshipful Grand Lodge of Kentucky, Free and Accepted Masons and its constituent lodges, and to all Masons to whom these presents may come, this sorrowful greeting:*

My Dear Brethren:

It is with profound sorrow that I officially announce to you the passing of our beloved Past Grand Master Columbus James "Colonel" Hyde who entered upon eternal rest, Friday, May 9, 2008, at Baptist Hospital East in Louisville, Kentucky.

Masonic Funeral Rites were conducted at the Highlands Funeral Home, 3331 Taylorsville Road, Louisville, Kentucky, by Sunset Lodge No. 915, F.&A.M. on Monday evening, May 12, 2008. Brother Harold L. Lee, Past Master of Aurora Lodge No. 633, F.&A.M conducted the Masonic Rites in excellent form. He was assisted by the officers and members of Sunset Lodge No. 915, F.&A.M., along with a large number of members of the Fraternity, Grand Lodge Officers and Past Grand Masters who were also in attendance. The Religious Services were conducted at the Highlands Funeral Home on Tuesday, May 13, 2008, 1:30 P.M. by the Bethany Baptist Church, Pastor Chuck Fuller, Dr. Lloyd Stormont and The Rev. Bill Anderson officiating. Interment was in the Resthaven Memorial Park Cemetery in Louisville, Kentucky.

Brother Hyde, the son of Tazwell Lee and Betty (nee James) Hyde, was born on December 19, 1916 in Brownsville, Edmonson County, Kentucky. He was educated in the public school system in Brownsville, Kentucky, subsequently, graduating from the Brownsville High School. He furthered his education by attending the University of Louisville, Southern Police Academy and the F.B.I. National Police Academy in Washington D.C. He served in the U.S. Army during World War II.

Brother Hyde was a law-enforcement officer in the city of Louisville for over forty (40) years, having served as chief of police from 1968 to

1971. He was unsuccessful in a bid for the office of Mayor of Louisville in 1973, later describing his candidacy as "the biggest mistake of my life". Brother Hyde was well respected by the Masonic Fraternity, his peers, professional associates and all who knew him. He gathered many honors and awards-too numerous to list in this short space - from many civic organizations, the Fraternity, and beyond, and he was always in demand as a speaker for fraternal, professional and civic organizations.

Brother Hyde and Miss Juanita Ford were married on December 8, 1935, and from that union were blessed with three daughters, Ellen, Betty and Annette, one son, James. Mrs. Juanita Ford Hyde passed away on August 11, 2004, just short of the seventieth anniversary of their marriage.

## FROM YOUR GRAND SECRETARY

### GRAND LODGE OFFICE CLOSED

The Grand Lodge Office will be closed Friday, July 4, 2007 in observance of Independence Day.

### NOTICE

Section 217 of the Book of Constitutions requires that all motions on resolutions pertaining to amendments of the Book of Constitutions of the Grand Lodge of Kentucky shall be submitted in writing and received in the Office of the Grand Secretary no later than August 15, prior to the Annual Communication.

### WAIVERS OF JURISDICTION

From time to time a Lodge may receive a petition for the degrees or for affiliation from one who does not reside within the jurisdiction of the Lodge petitioned. In such case, where the Lodge petitioned does not have jurisdiction, a request for a "waiver of jurisdiction" must be made to the Lodge within who's jurisdiction the petitioner resides. This rule applies whether the petitioner resides within or without the state.

Section 98 of the Book of Constitutions of the Grand Lodge of Kentucky, F.&A.M. defines a "waiver of jurisdiction" and specifies the procedure for granting or denying the same.

Periodically, questions are referred to this office regarding which Lodge is to conduct the character investigation on the petitioner- the Lodge petitioned or the Lodge from which the waiver is requested. The answer is both Lodges are to conduct an investigation. Section 98 (b) clearly charges the Lodge from which the waiver is requested to appoint a committee of three members to investigate and report on the character and qualifications of the petitioner. Further, the request must be received at a Stated Communication and one lunar month (28 days) must pass between its reception and a vote is taken thereon.

Likewise, Section 124 clearly states that a Lodge receiving a petition for initiation or affiliation shall refer the same to a committee of three members of the Lodge for inquiry into the character and qualifications of the petitioner. The petition must be received at a Stated Communication and one lunar month (28 days) must intervene between its reception and a ballot taken thereon- the same as noted above regarding the Lodge that made a request for a waiver of jurisdiction.

The Lodge making the request for a waiver does not have to wait until the Lodge from which

the waiver is requested to start their investigation.

The two investigations may be conducted concurrently. However, the Lodge making the request must not ballot upon the petition until the waiver has been granted, or the time limit has expired as noted in Section 98 (b).

Redundancy should not be a problem in such matter. The Lodge within who's jurisdiction the petitioner resides certainly has access to more personal history on the petitioner than the Lodge requesting the waiver, and should not grant a waiver in favor of one whom the Lodge membership does deem qualified. Likewise, the membership of the Lodge petitioned, as the result of the investigation conducted by their committee, must feel comfortable that the petitioner meets their qualifications for membership in their Lodge.

In my opinion, no petitioner can be over investigated. On the contrary, they can be- and are more often than not-uninvestigated.

### SERVICE AWARDS

By now you should have received, or will soon be receiving, your 50 & 60 year service award pins and 50 year service award cards. If you do not receive them by the 2nd week in July please contact one of the office staff at the Grand Lodge Office (502-893-0192). As soon as you receive the Service Awards from the Grand Lodge Office, they may be presented to the recipients immediately. The eligibility of each recipient has already been certified and the awards should be presented as soon as possible after they are received.

### YEAR-END ACTIVITY REPORTS

The office staff is gearing up at this time to verify the various lodge activities for the past year and to prepare the Annual Return information for each subordinate Lodge. With the exception of only a few Lodges, the Monthly Activity Reports have been received promptly in the Grand Lodge Office insuring an accurate up-to-date account of each Lodge activity. I urge each Lodge Secretary to take care of this important duty as quickly as possible in order for the Grand Lodge Office to assemble the information for inclusion in the Annual Report and presentation at the Annual Communication in October. The sooner we have the information the quicker we can prepare the Annual Return of your Lodge for verification.

The Annual Returns should be ready to mail from the Grand Secretary's office the last week in

July and, as Secretary, you should receive them around August 1, 2008. IF YOU DO NOT RECEIVE THE ANNUAL RETURN FOR YOUR LODGE BY AUGUST 10TH, YOU ARE INSTRUCTED TO NOTIFY THE GRAND LODGE OFFICE! Remember the deadline to return the verified Annual Returns to the Grand Secretary's Office is September 1, 2008. Payment of Lodge Assessments are also due at the same time. Late payment of Assessments and receipt of Annual Returns will cause a \$1.00 per day penalty for each discrepancy to be levied until each are received in the Grand Lodge office.

The office staff and I express to each Lodge Secretary our appreciation for your dedication and efforts in keeping our records accurate and up-to-date.




