AWARDS ELIGIBILITY LIST

Each Lodge Secretary will receive the "Award Eligibility List" from the Grand Lodge Office in early May for those eligible for the 50, 60, and 75 year Grand Lodge Veteran's Awards. You will be sent instructions with your list that will explain specifically how to fill it out. Please follow these instructions precisely.

The plateaus in time that a Brother must reach to qualify for these awards are significant, and the Grand Lodge Office wants to insure that those Brothers due the award receive it timely. So, we encourage you to give this review your close attention.

COMMUNICATION BETWEEN LODGES

Just a reminder to each Lodge Secretary, if you are communicating with another Lodge within the Grand Jurisdiction of Kentucky in an official capacity, you may correspond directly with the said Lodge. However, any correspondence to a Lodge - or Grand Lodge - other than the one within whose Jurisdiction your Lodge is located must be transmitted through the office of the Grand Lodge of Kentucky.

This procedure is intended to insure that a complete record of the particular transaction is fully noted at each level. Following this policy also saves time in as much as Lodges, agreeable to Masonic Protocol, will not directly respond to

correspondence from a Lodge outside their Jurisdiction - thus creating delays by stalling the correspondence.

Just remember, all out-of-state correspondence must be transmitted through the Grand Lodge Office.





MURRAY LODGE NO. 105 - PRESERVES HISTORY



The current renovation of the old Wallis Drug Store and Masonic Lodge building on the North side of the court square in Murray will preserve an important part of Murray-Calloway County history.

The building was constructed in 1866-1867. This was a joint effort between A. H. Wear, E. H. Covington (businessmen of the day) and Murray Lodge No. 105 F&AM.

Murray Lodge started in Wadesboro in August of 1844 and was moved to Murray in December 1844. The total cost of the building was \$5,094.35. The first Masonic meeting in the second floor of the building was in January 1867. Murray Lodge met in this building until 1974 when the new Lodge was finished on Ky. 121 North.

During the more than 160 years of existence, Murray Lodge has prospered under the leadership of many of the Murray community leaders. William Zelna Carter was elected to lead the Masonic Order in the State of Kentucky.

The list of leaders from the professional community is numerous. Equally important is the skilled craftsman who make up the membership.

Recently a number of members decided to erect a new sign to enhance the appearance of the facility and display the presence in the community. Max Weatherford, skilled metal craftsman, designed and made a permanent outdoor sign for the new Lodge building. Masonry craftsman, Elmo Thornton and Don Maupin, did the brick work.
