

## Kenneth W. Lawson Past Grand Master Passes

Kenneth W. Lawson Past Grand Master of the Grand Lodge of Kentucky passed away on Tuesday, July the 12th, 2011.

Brother Lawson served the Grand Lodge of KY as Grand Master in 1999-2000

He was elected as Grand Junior Warden, In October 1996. Served as Grand Senior Warden, 1997-1998, Deputy Grand Master, 1998-1999, and was elected to serve as Grand Master of the Grand Lodge of Kentucky, 1999-2000.

Brother Lawson served as Master of Fern Creek Lodge No. 955 in 1974 and was the Charter Secretary of Zoneton Lodge No. 964.

Brother Lawson served the Grand Lodge of Kentucky as Grand Chaplain in 1987, 1991, and 1994; District Deputy Grand Master in 1993 and the Religious Interest Committee for four years.

Brother Lawson was a member of the Order of Eastern Star, Zoneton Chapter No, 576, Past President of the Society of Past Masters of Central Kentucky, Jefferson County Officers Association, Masonic Board of Relief, and Life Director of the St. Johns Day League .Brother Lawson was a 32° KCCH Scottish Rite Mason, a member of the York Rite Bodies, where he served the York Rite as Grand Chaplain, and a member of Kosair Shrine.

Brother Lawson was a United States Army veteran who served during World War II and retired from GE in 1986 after 31 years of service.

He was the former pastor of Mt. Elmira Baptist Church and Clermont Baptist Church.

Among those who preceded him in death include, his first wife, Ruth Lawson; son, Ronnie Lawson and daughter, Janice Dishon.





# Grand Master's Message

The Committee on Masonic Education has done a very good job this year. They designed a program that has been well discussed in our Lodges. A program that was well discussed by those who attended. Some have taken it out of context some have distorted it and some simply got it. I have had many calls and e-mails about what was discussed in the meetings as to why the Grand Lodge was trying to take God and The Pledge out of our Lodges. Let me state there is NO truth to the rumor. The Education Committee and the Grand Lodge Officers have only brought to you what is in the Constitution and Landmarks of our Fraternity.

Freemasonry has no religious doctrine. There are

Masons of all faiths and your faith may not be the same as the Brother sitting next to you. When you may be asked to pray we ask that you consider whom you may be praying for, and are all of the same faith? That was the point the Committee was trying to make clear.

The Book of Constitutions is laws set forth by Kentucky Masons for Kentucky Masons. It is the Book that Masons for many years, have said this is what we as Masons should be following. Yet many of our Lodges do not even have an updated constitution. It is time we as members of our Lodges take ownership of the Constitution and see that our Lodges and the Officers follow our laws. These are laws adopted by members of your lodge that attended Grand Lodge session. They are laws that the Craft of Kentucky, not the Grand Lodge Officers, have made. You elected these Officers to uphold the Constitution and to enforce your rules and laws. Yet it's not just our duty it is the duty of every Mason to follow the designs that have been laid out for us to be the best Mason we can be.

This year we are having a Grand Master's Golf Scramble on Monday the 26th of September. This will benefit the Brick by Brick program at the Masonic Homes. We will be having a Challenge Trophy for the Lodges. They must be members of a Lodge under a Lodge name to try for the Trophy. The team from a Lodge with the lowest score will have their names placed on this Trophy, and will retain it until the next years Scramble at which time it will be returned to be won again. I hope many of the Lodges would consider this and send a team to play in this event. There is more information in this issue of the Journal.

## FROM YOUR GRAND SECRETARY

While the “social media network” (Facebook, Twitter, etc.) has been around on the internet for a while, and has become a fast growing phenomenon with many making use of the technology, it is still in the infancy stage and going through a learning curve. There are many great benefits to be gained from this technology such as instant and mass world-wide communication, making friends, exchanging ideas, learning of other cultures, and is a positive addition to the modern technological tools we have available at our fingertips for good. However, there is also a down side. Since the internet is not private, the potential for using the technology for doing mischief is always prevalent, as witnessed by the number of incidents of cyber-bullying, slander, and alleged disclosure of privileged, private, and confidential information by some using the social media network.

On several occasions during the past few months, calls from concerned members of the Craft have been received in the Grand Lodge Office about the propriety of some of the material being posted on the internet by the social media network medium regarding what they consider private and confidential Masonic information; i.e. reports of conferral of degrees, membership suspension information, etc. Their one overriding question was how does the Book of Constitutions deal with the matter? While the Book of Constitutions doesn't address the matter specifically, it does so in general. According to Roscoe Pound, secrecy is one of the six recognized fundamental landmarks of Freemasonry (number five by H. B. Grant), and is a universally recognized tradition of the Fraternity. As Freemasons, we have all taken an oath to abide by the landmarks, established customs and traditions of Freemasonry,

and are admonished to act accordingly.

Consequently, while there are many things we as Masons may share with the public—on the internet or otherwise—we should be very cautious about maintaining our privacy and not going over the line; thereby unwittingly violating our oath and obligation.

### NOTICE

Section 217 of the Book of Constitutions requires that all motions on resolutions pertaining to amendments of the Constitutions or Laws of the Grand Lodge shall be submitted in writing and presented to the Office of the Grand Secretary no later than August 15, prior to the Annual Communication

### NOTICE

Section 12 (3) of the Book of Constitutions requires that an Elective Representative be a Permanent Member chosen by ballot from the members of his lodge, to represent it in case its Master, Wardens or Secretary cannot attend the communication of the Grand Lodge, and such representative shall be given a certificate of his election over the lodge seal.

### SUSPENSIONS

Each year a few reports are received in this office of members being suspended on other than a Stated Communication of the Lodge-- most always on the last day of June. Section 176 of The Book of Constitutions specifies that the suspension of a member is to occur at the stated communication set in the summons and the suspension is complete at that time.

The suspended member may become reinstated the next day in accordance with Section 187, merely upon payment of the

amount owing up to the time he was suspended. However, that does not alter or erase the fact that the suspension occurred, and should be recorded as such.

Further, if the suspended member is a Plural Member, it is the primary responsibility of the suspending Lodge to notify the other Lodge(s) of which he is a member of the suspension in order for them to take appropriate action. As a follow-up the other Lodge(s) also receives a notice of the suspension from the Grand Lodge Office as soon as the information is received from the suspending Lodge.

### YEAR-END ACTIVITY REPORTS

The office staff is gearing up at this time to verify the various lodge activities for the past year and to prepare the Annual Return information for each subordinate Lodge. With the exception of only a few Lodges, the Monthly Activity Reports have been received promptly in the Grand Lodge Office, insuring an accurate up-to-date account of each Lodge activity. I urge each Lodge Secretary to submit their monthly report in ample time to permit the assembling of the information for the Annual Report and presentation at the Annual Communication in October. The sooner we have the information the quicker we can prepare the Annual Return of your Lodge for verification.

It is not necessary to delay mailing the Annual Returns to the Grand Lodge Office until payment of the assessments is made. Once the Annual Returns are reviewed and verified, they should be mailed promptly to the Grand Lodge Office so the statistics can be prepared in ample time to complete the Advance Proceedings before the Annual Communication. The assessments payment may be submitted at a later date (prior to

September 1, to avoid a penalty).

Remember the Annual Return must be received in the office of the Grand Secretary prior to the September 1, 2011 deadline. The payment for Grand Lodge assessments is also due at the same time. Late payment of the Grand Lodge assessments and/or the Annual Returns will cause a \$1.00 per day penalty to be assessed for **each** discrepancy until they are received in the Grand Lodge Office.

## STAY COOL THIS SUMMER

Ceiling fans can be your salvation. If you're looking for ways to beat the heat, a ceiling fan can be a great investment for your home. This one appliance can make a room feel 6 or 7 degrees cooler, and even the most power-hungry fan costs less than \$10 a month to use if you keep it on for 12 hours a day. Good fans make it possible for you to raise your thermostat setting and save on air-conditioning costs.

If you have air conditioning, use it wisely. Don't put lamps, televisions or other heat-generating appliances next to your air-conditioning thermostat. They'll prevent the air conditioner from operating as efficiently as it should. If you have a window air conditioner, be sure to use it in concert with a fan that moves cool air throughout your home.

Get with the program. Here's another way to lower your energy bills: Use a programmable thermostat that adjusts your air conditioner's setting automatically. This allows you to stop cooling things down so much when nobody's home for long stretches of time, or at night when it's cooler outside. You can program the thermostat to increase the comfort level in your home shortly before you wake up or return home from work.

Don't give your cool air away. If you rely on air conditioning, you're probably paying dearly for that cool air. Effective caulking and weather stripping will keep it from seeping right out of your house. Check for holes or separated joints in your air-conditioning ducts, and add insulation around ducts in attics, crawl spaces and garages.

Adapt to your environment. Do you live in a house with an attic that's trapping enormous amounts of heat? If so, a whole-house fan could be well worth the investment of \$150 to \$400. Such fans pull air through open windows in your home and exhaust it through your attic and roof. Even if you don't have a whole-

house fan, properly placed roof vents and louvers also can help ventilate your attic and reduce heat levels in your home. Or if you live in a dry climate, you might want to invest in an evaporative cooler or "swamp cooler." It cools outdoor air by pulling it over pads saturated with cold water. The cooled air gets sent into your home, and warmer air gets pushed outside through your partially opened windows. These systems cost between \$200 and \$600 and use significantly less energy than central air conditioning in low-humidity climates.

Your windows matter. Opt for white window shades, blinds or drapes to reflect heat away from the house, and be sure to close curtains on south- and west-facing windows during the day. Depending on the severity of the heat where you live, you also can use sun-control or other reflective films on south-facing windows and mount awnings over them.

Hug a tree. Three trees situated strategically on the south and west sides of your house can reduce your utility bill by \$100 to \$250 a year. Tree-shaded yards and neighborhoods have daytime air temperatures that are several degrees cooler than comparable areas without trees.

Find cool ways to escape. Again, you may be in a situation where the above-mentioned fixes are simply beyond your reach or your control. No matter what, you can dream up ways to escape the heat this summer on your own or with your whole family. Some ideas:

- Catch a reduced-price matinee movie during the daytime in an ice-cold movie theater.
- Kick back at the library and read for hours — and while you're there, check out all sorts of movies, books and music for free.



I don't recall the very first time I met Ken Lawson... he was just that type person... humble and unassuming. However, when something needed done he was always around and willing to pitch in... he just seemed to have always been there. He was a proud Mason and one willing to give his all for the Fraternity, a true Mason. He practiced both his Religious Faith and the tenets of Freemasonry daily 24/7. Friendship, Morality and Brotherly Love were much more than noble sounding words for Ken... they were the core of a code he lived by every waking moment of his life. His love and devotion to his God and the Lord Jesus Christ, his family, his country, his friends and Brethren were genuine and obvious to all who knew him. Ken's reaction and response to some of the difficulties, disappointments and tragedies which befell him during his lifetime should serve as an example for us all to follow.
