





“GIRD UP YOUR LOINS”

“I Didn’t Know That.....”

While reading a list of “Famous Freemasons”, I ran across the name of Eileen Gray. Curiosity led me to seek information on her life as well as her masonic affiliations. Her obituary states that she was a cyclist and sports official born April 25, 1920 and passed away at the age of 95 years on May 20, 2015. It also mentions that she was a longstanding member of the ‘Honourable Fraternity of Ancient Freemasons’, one of two orders of female freemasons located in the U.K. Her story is fascinating.

Although women’s sports even today, are not as influential as the men’s, as was certainly the case in women’s cycling in the 20th century, it was Eileen Gray who paved the way to raise women’s cycling from an ‘unheard of’ status to Olympic status. It was during World War II that Eileen Gray would bicycle from her home in south-east London to her factory work in north-west London. Finding it enjoyable, she eventually joined a cycling club that accepted women, when most other cycling clubs did not.

In 1946, two major happenings changed her life. She married racing cyclist and promoter Walter Gray. Later that year, she and two other women riders, the first British international racing team, raced at a site near Copenhagen. Later in life Gray stated that they won but, “They just as wanted us there a sideshow, but what they didn’t realize was, that they had given us a platform, visibility and a chance to show what we could do. Other women saw us too, and must have thought: ‘If they can do it, so can I’, and from that point on, something started”.

For years Gray fought to get women’s events included in the world championship. In 1955, an attempt for a world record was finally agreed to, upon condition the ladies furnished their own sandbags to meet official safety regulations, but afterwards, the delegates at the National Cyclists Union (NCU) “forgot” to make a motion for recognizing women’s world records. Although some small success did follow, it was not until 1958 that the 1st women’s world race title was held in Reims, France. Then during the 1960 world championship held in Leipzig, Germany, the NCU refused to supply the women’s team with a team kit. The women were given a small allotment and were expected to purchase everything else themselves. In what Gray considered an act of sabotage, a team staff member left the event early, and took tubes and tires that the women had paid for. But on a positive note, Britain’s Beryl Burton, the strongest female cyclists in the world, won two gold medals, and sprinter Jean Dunn won a bronze medal.

Times do change, and the NCU was renamed the British Cycling Federation. Eileen Gray served as its president from 1976 to 1986. It was during her reign that women’s cycling finally was included in the 1984 Olympic Games. According to her biography, Eileen Gray wrote a column for the “Cycling Weekly”, served as vice-chair of the British Olympic Committee, and in 1992, she was deputy commandant of the British teams. Eileen founded the London Youth Games, was a Conservative councilor and later served as Mayor in Kingston upon the Thames, and in 2010 was nominated to the British Cycling Hall of Fame. In 2012, Gray was torchbearer for the London games.

Eileen Gray was appointed a Member of the Most Excellent Order of the British Empire (MBE) in 1978 and Commander (CBE) in 1997.

Eileen Gray’s masonic career is equally impressive. In June, 2005 she was interviewed for a London radio program. “There’s only one thing more mysterious than Freemasons, and that’s women Freemasons. The controversial brotherhood is widely thought to be a male-only preserve, but sisters, or should that be “brothers”, are doing it for themselves”, so the program began.



The commentator resumed, “She is the head of The Honourable Fraternity of Ancient Masons, one of the two orders of women Freemasons in this country. The fraternity has been around for nearly 100 years and has a membership in the region of 1,000 women. Its headquarters are in north London, and there are lodges all across the country and overseas too. The Freemasons here follow the same ceremonies and practices as their male counterparts, bizarrely even calling each other “brother”.

Eileen Gray quipped, “I know I don’t look like the Duke of Kent [her equivalent in male Freemasonry], but it’s the same sort of situation. We were formed from the men and we followed the men in practice, we use their ritual and it comes naturally to be brothers in a Fraternity”. She went on to say on radio, that women from all backgrounds belonged to the fraternity and “It means different things to different people. It broadens one’s outlook on life, and gives different interpretations. We see people come in who are not used to the business world, not used to learning the ritual, and as they learn the ritual, that gives them confidence in public speaking, and it’s really nice to see so many people blooming with their self-confidence.” Charity to good causes is also important to the lodge.

She then noted that women have been involved with masonry at least since 1277, when recorded that a women mason worked on the carvings on the porch of Strasbourg Cathedral. Gray followed with the story of Lady Elizabeth St. Leger (also known as Lady Aldworth), the lady mason of Cork County, Ireland, before the Grand Lodge era. She talked about women’s lodges in France in the early 18th century, and later when female lodges were established England in 1913. Eileen Gray then concluded, “We are not a secret society we are a society with secrets. People think that because something is secret there’s got to be something wrong with it. And it’s not particularly secret, but because it has its rituals within it, which are known to those that participate, it can sound weird to people”.

Women in Masonry are in general, fully recognized by Continental Masonic Lodges (Grand Orients) only. However In 1999, the United Grand Lodge of England (UGLE) issued a statement acknowledging



the 'regularity and sincerity' of the women's Freemasonry. Though not officially recognized by UGLE, and male members cannot participate, informal relations with the women lodges are cordial, with many of the women meeting in temples owned by their male counterparts. The UGLE has worked with the women in such things as charity projects and open houses in Freemasons Hall, to promote the two female groups.

So will this lead to full recognition? Probably not, as this would require a major change in UGLE by-laws which describes itself as a male organization open only to males, but congeniality definitely exists between them.




