#### ARTICLE 9 SECTION 8-BY-LAWS. Section 55

The Committee on By-Laws shall examine the by-laws of subordinate lodges and amendments thereto, except amendments to by-laws changing the time and date of communication of lodges.

By-Laws shall not become effective until they have been approved by Committee on By-Laws and lodged for record by the Grand Secretary who will endorse the same and notify the lodge of the Committee's action. Decisions of the By-Laws Committee shall be conclusive until reversed or modified by the Grand Lodge. Reports of the By-Laws Committee, with the names and numbers of the lodges whose by-laws it may have passed upon, shall be made to the Grand Lodge.

(Proposed to Read)

#### ARTICLE 9 SECTION 8-BY-LAWS. Section 55

The Committee on By-Laws shall examine the by-laws of subordinate lodges and amendments thereto, except amendments to by-laws changing the time and date of communication of lodges.

*Although amendments to by-laws changing the time and date of communications do not require review or approval of the By-Laws Committee, they shall NOT become effective until the new meeting time and date are entered into the Grand Lodge Database.*

By-Laws shall not become effective until they have been approved by *the* Committee on By-Laws and lodged for record by the Grand Secretary who will endorse the same and notify the lodge of the Committee's action. Decisions of the By-Laws Committee shall be conclusive until

#### ARTICLE 13

##### Section 6- Burial of a Suspended Mason

In the case of a deceased Mason who has been suspended for non• payment of dues, if after notice to the Master ( or Senior Warden or Junior Warden in that order) and proper inquiry, the Master ( or Warden ) of the Lodge determines that such non-payment was due to the Brother's lack of mental capacity realize he was in arrears ( and/or suspended) due to a physical or mental disability resulting from an injury or disease, the Master of the Lodge may approve Masonic Burial Service for said Brother. (2018)

(Proposed to Read)

In the case of a deceased Mason who has been suspended for non-payment of dues, if after notice to the Master (or Senior Warden or unior Warden in that order) and proper inquiry, the Master (or Warden) of the Lodge determines that such non-payment was due to the Brother's lack of mental capacity realize he was in arrears ( and/or suspended ) due to a physical or mental disability resulting from an injury or disease, the Master of the Lodge may approve Masonic Burial Service for said Brother. (2018)  
*If a Mason has attained 50 years of service in good standing before being suspended for non-payment of dues, he shall be entitled to receive a Masonic Funeral upon request by his family."*

##### SECTION 3 – NUMBER ON EACH Section 50

The Committees on Biography, Necrology and Proceedings of other Grand Lodges shall each consist of only one (1) member; the other committees shall each consist of three permanent members of the Grand Lodge except as otherwise provided herein. The Committee on Masonic Education shall consist of no less than three and no more than six permanent members of the Grand Lodge. The Committees on Biography, Necrology and Proceedings of other Grand Lodges shall each consist of only one (1) member; the other committees shall each consist of three permanent members of the Grand Lodge except as otherwise provided herein. *The Committee on Masonic Education shall consist of no less than three and no more than the number of Lodges of Research with one additional member as chairman, members of the Grand Lodge. The Committees on Masons Helping Masons and Veterans Affairs shall consist of no less than three and no more than half the number of districts for each committee, and one additional member as chairman of each committee, all being permanent members of the Grand Lodge except as otherwise provided herein.*

### ITEM NO. 1

(Currently Reads)

ARTICLE 11 (D) JURISDICTION

SECTION 1- GENERAL RULE. SECTION 95

The jurisdiction of every lodge, except as in ARTICLE 11 (SECTION- D) (2, 3), shall extend halfway to the nearest lodge meeting location by a straight line measurement in any and every direction.

SECTION 2- CITIES HAVING TWO OR MORE LODGES. Section 96

In the cities having two or more lodges the jurisdiction shall be concurrent and extend as provided in ARTICLE 11 (SECTION- D)(1), except, Adair, Allen, Anderson, Ballard, Barren, Bath, Bell, Boone, Bourbon, Boyd, Boyle, Breckinridge, Bullitt, Butler, Calloway, Campbell, Carter, Casey, Christian, Clark, Clay, Daviess, Estill, Fayette, Floyd, Grant, Grayson, Green, Greenup, Hardin, Harlan, Harrison, Hart, Henderson, Henry, Hopkins, Jackson, Jefferson, Jessamine, Johnson, Kenton, Knox, LaRue, Laurel, Lawrence, Lewis, Lincoln, Livingston, Logan, Lyon, Madison, Marion, Martin, Marshall, McCracken, McCreary, Mercer, Metcalfe, Monroe, Morgan, Nelson, Nicholas, Ohio, Oldham, Owen, Owsley, Pendleton,

Perry, Pike, Pulaski, Rowan, Russell, Shelby, Simpson, Taylor, Todd, Trigg, Washington, Wayne, Webster, Wolfe and Woodford counties, the jurisdictions shall be concurrent within said counties and extend as provided in ARTICLE 11 (SECTION- D)(1). Boone, Grant and Kenton counties shall be regarded as one jurisdictional unit. Henderson, Union, and Webster counties shall be regarded as one jurisdictional unit. (2020)

SECTION 3- NEAR STATE BOUNDARY. Section 97  
The jurisdiction of lodges near the borders of other states may extend half way to the nearest lodge in such other Grand Lodge jurisdiction provided there be an agreement to that effect between such Neighboring Grand Lodge and this Grand Lodge, and further provided if the petitioner lives in Kentucky he shall have a choice of jurisdiction, except in Pike County, Kentucky and Mingo County, West Virginia. (2001)

SECTION 4- JURISDICTION WAIVED. Section 98a  
Waiver of Jurisdiction may be given by any lodge possessing jurisdiction over a candidate for degrees or affiliation, in favor of any other lodge. In such cases, the lodge in whose favor the waiver shall be made may entertain the petition of such candidate as if he had resided within the jurisdiction thereof the required period of time. In all cases where the fee of the lodge granting the waiver of jurisdiction is greater than the fee of the lodge requesting the waiver the candidate shall pay to the lodge which asks the waiver a fee equivalent to the fee he would have been required to pay had he petitioned the lodge which granted the waiver. Immediately after the candidate is elected and initiated, the Secretary of the lodge receiving the waiver shall send the difference in fees to the lodge granting the waiver.

SECTION 5- WAIVER OF JURISDICTION—HOW GRANTED. Section 98b

Waiver of Jurisdiction can only be granted by a lodge having jurisdiction, and upon request made by a lodge, over its seal, to which the petition for degrees or membership has been presented. The request may be sent by first class mail, electronic mail, or hand delivered. The answer or reply will be sent by similar manner. Before granting the waiver, the application will be referred to a committee of three members of the lodge for inquiry into the character and qualifications of the petitioner mentioned in such request. Such request can only be received at a stated communication and one lunar month must intervene between its reception and ballot thereon. The vote on the waiver shall be by ballot, and if as many as three votes be cast against the waiver the request shall be refused.

Within the state, jurisdiction will be waived automatically 90 days after a request for waiver is sent to the secretary of the lodge possessing jurisdiction unless the lodge possessing jurisdiction denies the waiver and notifies the requesting lodge in writing prior to the 90th day. For just cause the lodge possessing jurisdiction may impose one extension of not more than thirty days with written notification to the requesting lodge prior the 90th day. At the end of such extension the jurisdiction will be waived automatically unless the lodge possessing jurisdiction denies the waiver and notifies the requesting lodge in writing prior to the end of the extension. Automatic waiver of jurisdiction does not apply to requests for waivers to or from other Grand Jurisdictions. (2018)

If a waiver of jurisdiction is granted and the petitioner is subsequently rejected by the requesting Lodge, the jurisdiction shall return to the Lodge for the person as designated in Article 11, Section 1 (D) and a new waiver

would be needed before the petitioner could join any other Lodge. (2019)

SECTION 6 - INVADED JURISDICTION. Section 99  
A lodge that receives the petition and initiates a candidate, or admits to membership a brother from a jurisdiction not its own, in violation of the provision of ARTICLE 11 (SECTION- D) (1- 4), shall forfeit and pay the fees to the lodge which lawfully held jurisdiction, and be subject to having its Charter arrested, or such other penalty as the Grand Lodge shall impose.

SECTION 7 - MOVING FROM JURISDICTION. Section 100

Moving from the jurisdiction of a lodge does not forfeit lodge membership. If he is an officer of a lodge, a brother does not forfeit such office if he is able to attend with reasonable regularity, otherwise he will be subject to ARTICLE 11 (SECTION- B) (5).

ARTICLE 11(D)- JURISDICTION

**SECTION 1- GENERAL RULE.**

*The jurisdiction of every subordinate lodge shall extend to the several boundaries of this Grand Jurisdiction and be concurrent.*

**SECTION 2- BACKGROUND CHECKS**

*All petitions for degrees, petitions for affiliation by dual membership (out of state), petitions for affiliation by transfer (out of state) petitions for affiliation by demit, and petitions for restoration (after one year has lapsed since suspension) shall have a background check completed and the results transmitted to the Master and Secretary of the lodge petitioned, prior to the report of the investigation committee being presented. Such background checks shall be completed by The Grand Lodge of Kentucky F. & A.M. and will be of no cost to the subordinate lodge.*

*Petitions for affiliation by dual membership (in state), petitions for affiliation by transfer (in state), and petitions for restoration (less than one year having lapsed since suspension) shall not need to have a background check completed.*

**SECTION 3-WAIVER OF JURISDICTION-  
HOW GRANTED IN KENTUCKY.**

*Waiver of Jurisdiction may be granted by the Grand Master of The Grand Lodge of Kentucky F& A.M., following receipt of the background check results, on candidates who fall under the jurisdiction of the Grand Lodge of Kentucky and petition out of state lodges.*

**SECTION 4- WAIVER OF JURISDICTION-  
HOW GRANTED OUTSIDE OF KENTUCKY.**

*Waiver of jurisdiction may only be granted by a Sister Grand Lodge having jurisdiction, and with the results being returned to The Grand Lodge of Kentucky F. & A.M. and these results being forwarded to the subordinate lodge that requested it before they can act on it. No ballot shall be cast on a candidate for whom another Grand Jurisdiction possesses jurisdiction may be conducted until a Waiver of Jurisdiction has been received by The Grand Lodge of Kentucky F. & A.M. and forwarded to the subordinate lodge requesting such.*

**SECTION 5- INVADED JURISDICTION.**  
*A lodge that receives the petition and initiates a candidate or admits to membership a brother from another Grand Jurisdiction not its own, are in violation of the provision of Article 11(D) (1-5), shall be subject to having its Charter arrested or such other penalty as The Grand Lodge of Kentucky F. & A.M. shall impose.*  
**SECTION 6- MOVING FROM JURISDICTION.**  
*Moving from the jurisdiction of a lodge does not forfeit*

A lodge under dispensation may be established on the petition of not less than 15 Master Masons, residents of the jurisdiction of the proposed new lodge, who shall file with said petition their demits or statements of good standing, certified and sealed by the Secretaries of their lodges, and the consent of every lodge whose jurisdiction would be affected by the new lodge if established. Should the proposed new lodge be located in a city in which there are three or more lodges, the consent of a majority only of said lodges shall be required before a dispensation can be granted for the formation of the new lodge, provided, however when a subordinate lodge reaches a membership of 200, its consent shall not be required for the creation of a new lodge in its jurisdiction. The petitioners shall also file the certification of the lodge selected by the Grand Master which shall state that the proposed Master and Wardens have been examined audibly in said lodge and found capable of doing the work of the symbolic degrees in a creditable manner. (2001)

ARTICLE 28- LODGES UNDER DISPENSATION  
SECTION 2 - HOW TO ESTABLISH A LODGE UNDER DISPENSATION. Section 191

A lodge under dispensation may be established on the petition of not less than 15 Master Masons, residents of the jurisdiction of *The Grand Lodge of Kentucky, F. & A.M.*, who shall file with said petition their demits or statements of good standing, certified and sealed by the Secretaries of their lodges, and the consent of every lodge *within a ten-mile radius of the physical address of the proposed lodge under dispensation, regardless of the number of members of said lodges.* The petitioners shall

also file the certification of the *Committee on Lodges Under Dispensation* which shall state that the proposed Master and Wardens have been examined audibly in said lodge and found capable of doing the work of the symbolic degrees in a creditable manner. (2001)

ARTICLE 21- GRAND LODGE ASSESSMENTS

No lodge shall be required to pay Grand Lodge Assessments on any member thereof, who for a period of fifty years, shall have been affiliated with a lodge, or lodges, of Free and Accepted Masons in Kentucky or any other Grand Jurisdiction recognized by it.

ARTICLE 15- (B) PETITION FOR MEMBERSHIP  
SECTION 12 – OBJECTION. Section 134

(1) An objection to initiation, advancement or affiliation may be made by a member of the lodge, and the objection to initiation or affiliation shall have precisely the same effect, in every respect, as if the objector had cast an unfavorable ballot on the petition. An objection, to be valid, must be made before the preparation of the candidate in the case of initiation or advancement and before the ballot is taken in the case of affiliation. “Before the preparation of the candidate” shall be defined as before the candidate is conducted to the preparation room. (2) Objection to advancement shall prevent the candidate from receiving the degree for six months from the date the objection is, or should have been noted in the minutes: and after the expiration of six months the candidate may be advanced upon request without formal petition, but notice shall be given of the proposed advancement in open lodge. (3) Objection may be renewed, or other objection made in like manner and with the same effect within one week before the end of the six-month period or any succeeding six month period. (4) Such objection may be made in open lodge or to the Master privately and if made at a stated communication the objection shall be noted in the minutes without giving the name of the objector; and if not made or reported at a stated communication, then in every case the objection must be noted in the minutes of the next stated communication as above provided.

(5) The objecting brother shall not be questioned as to his reasons, but he may give them if he chooses, and if he voluntarily states his reasons in open lodge, or privately to the Master who shall preserve the identity of the Brother

making the objection and shall not reveal his identity to anyone, the lodge shall pass upon the sufficiency and validity of the objection, and a majority vote by ballot shall be necessary to sustain the objection. If not sustained the lodge shall proceed with the advancement of the candidate.

(6) Any objection to advancement may be withdrawn by the objector in open lodge, or to the Master privately and the withdrawal must be noted in the minutes at a stated communication and the candidate may then be advanced.

(7) (G) Unless charges are preferred, no objection shall prevent an Entered Apprentice or Fellow Craft Mason from participating fully in any degree which he has attained, or having a demit issued to him as provided in ARTICLE 18,( SECTION- 3).

ARTICLE 15- (B) PETITION FOR MEMBERSHIP

If the members concur with the objection, the objection for initiation or affiliation shall have precisely the same effect, in every respect, as if the objector had cast an unfavorable ballot on the petition. An objection, to be valid, must be made before the preparation of the candidate in the case of initiation or advancement and before the ballot is taken in the case of affiliation. “Before the preparation of the candidate” shall be defined as before the candidate is conducted to the preparation room.*

(2) Objection to advancement shall prevent the candidate from receiving the degree for six months from the date the objection is, or should have been noted in the minutes: and after the expiration of six months the candidate may be advanced upon request without formal petition, but notice shall be given of the proposed advancement in open lodge.

(3) Objection may be renewed, or other objection made in like manner and with the same effect within one week before the end of the six-month period or any succeeding six month period.

*The petitioner must be willing to voluntarily consent to a background check included with the petition for initiation for the degrees, which shall be submitted during the 1st lunar month waiting period and shall be processed and paid for by the Grand Lodge of Kentucky. If the petitioner does not voluntarily consent to a background check pursuant this amendment, the investigation committee must be informed that the candidate was unwilling to voluntarily consent and may proceed accordingly. If the Grand Lodge of Kentucky has not informed the subordinate lodge of the status of the background check or is unable to complete the process in the allotted one lunar month waiting period; the responsibility and duty to decide how to proceed will rely on a two-thirds majority vote of the subordinate lodge to which the petition was received.*

Per the duties of the Jurisprudence Committee as outlined below in ARTICLE 9, SECTION 11: JURISPRUDENCE, The Jurisprudence Committee may make any recommendations to the craft that the items be put together and voted on collectively by the subordinate lodges of the Grand Lodge of Kentucky.*

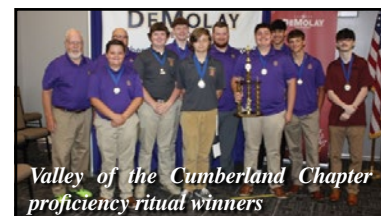

*"I Didn't Know That....."*

PART THREE – LEXINGTON

Having left Frankfort for Lexington and with a mounted company escort led by Colonel John Steele, Lafayette and his companions stopped for midday dinner at Brown's Wood, just outside of Versailles. Versailles, then a small town with a population of less than 1,000, honored the Marquis with a reception, where he met with old friends and veterans of the Revolution. The event was noted by the Marquis' secretary, Augustus Levasseur in his journal stating that the event took place in "a pretty little town of Versailles." Despite typical Kentucky spring rains, the sun was bright and the wild flowers were in bloom as the ensemble made their way to spend the evening and night in the large brick house, owned by Major John Keen. The military camped on the large grounds. The property would later be known as *Keeneland Race Track*.

From the Marquis' arrival in New York August 15, 1824, the Lexington Trustees wanted Lafayette to visit. Within a week of his arrival, Horace Holley, president of Transylvania University, invited Lafayette to Kentucky. That invitation was later accepted in a letter sent to Henry Clay (PGM 1820-21) then serving as Speaker of House of Representatives. Kentucky Masonic historian Charles Snow Guthrie "*Kentucky Freemasonry 1788 – 1978*" states as does other historians, Lexington was at that time, "the cultural and commercial center of the state." Masons were abundant in political and social affairs. At the time of Lafayette's visit, the Grand Lodge of Kentucky then held in Lexington, was almost 25 years old and had constituted nearly eighty lodges, many without the Kentucky's border. The new Grand Masonic Hall was nearly complete and more than ample to hold receptions. Transylvania College, the oldest college west of the Alleghany Mountains having been established in 1780, gave rise to Lexington being regarded as "The Athens of the West." Lexington had waited nine months for Lafayette's arrival and were well prepared to honor the "Nations Guest" on a level previously unknown in Kentucky and unexcelled in the nation.

The next morning, May 16, 1825, the Fayette Committee arranged for a military escort of three companies (*the Fayette Hussars – the Woodford Troop of Horse – the Georgetown Troop*), to conduct the Marquis and his guests to their lodging at Mrs. Sanford Keen's Tavern, in Lexington. Again, typical of Kentucky spring weather, it had rained throughout the night, but in the early morning the sun broke through in time for a large procession to join the escort to Lexington and to the Marquis' quarters. John Bradford, founder and editor of *The Kentucky Gazette*, and Chairman of the Trustees, in an emotional address welcomed Lafayette and his companions. Lafayette replied in a gracious but meaningful way and afterwards, many military personnel, including old timers from Revolutionary days, came forward to grasp his hand. The Marquis was the last living General of the Revolution and the greeting of old friends must have been emotional for him.

Transylvania University was on the list of points to visit, as was the Lexington Female Academy. Lafayette was accompanied by the Governor of Kentucky and the Governor of Tennessee. At both schools, orations, tributes and odes were recited, some in English, some in French

and some in both languages, all in patriotic praise of the distinguished guest. Students also honored the Marquis with musical numbers during the visit of the two schools. This type of literary program had not been previously presented at any other school in the nation and Lafayette made appropriate responses to all. The above speeches, odes and music, were felt worthy of being recorded and can be found in "*La Fayette in Kentucky*" authored by Edgar Erskine Hume.

The Marquis found time to visit with the widow of Revolutionary officer, and War of 1812 hero, and old friend, General Charles Scott for whom Scott County is named. He then reviewed some troops, and stopped by *Ashland*, the family home of Henry Clay, for a visit. The day was not over yet.

The Fayette Committee had previously printed an invitation with masonic and patriotic emblems, for a dinner and dance to be held at the Grand Masonic Hall. Renowned Kentucky historian J. Winston Coleman Jr. in his book "*Masonry in the Bluegrass*" notes, the invitation had the all-seeing eye, two pillars, checkered pavement, an eagle and two American flags surrounding Lafayette's picture. It was printed in *Royal Arch* scarlet red ink and signed by twelve Masons. Over 800 men and women responded to the invitation. The ever gracious Lafayette is said to have danced with many of the ladies present. Tired and in all probability totally exhausted, he left the reception before midnight. In all likelihood, the Committee was equally exhausted.

Lodge member Mathurin Giron, at that time considered the most famous caterer in the west, made a large castellated cake for the event. It was so admired, that it was not cut, but saved for the next day's breakfast. Then it was decided to wait again for Grand Lodge to meet, thinking displaying it may improve attendance. This story was told for years, and the cake became quite famous.

The Marquis was up early the next day to sit for the famous Jouett portrait. The Lexington Trustees had commissioned the painting months earlier and artist Matthew H. Jouett had completed most of the painting, but needed the Marquis present to add his facial details. Lafayette then attended the Masonic breakfast at the Grand Hall where the Reverend Mr. Ward gave a speech "of great pertinency and excellence" to which the General was "uncommonly happy in his reply." Robert Breckenridge McAfee, Lt. Governor of Kentucky, presented a copy of his book "*History of the Late War in the Western Country*." In what must have deeply touched Lafayette's heart, Colonel Woodford presented the Marquis with a military sash, worn by his father, Lafayette's good friend, William Woodford, during the Revolution. The breakfast now over, many of the brethren conducted Lafayette to his quarters at Mrs. Stanford Keen's Tavern, to rest and prepare for tomorrow's venture.
