

"I Didn't Know That....."

One Masonic curiosity can be found in a book titled "*History of Rhode Island*" printed by John S. Taylor, New York, 1853 and authored by the Rev. Edward Patterson. On pages 101-102 of the 400 page history, we find:

MASONIC FRATERNITY "In the spring of 1658, Mordecai Campannell, Moses Packeckoe, Levi, and others, in all fifteen families, arrived at Newport from Holland. They brought with them the three first degrees of masonry, and worked them in the house of Campannell, and continued to do so, they and their successors, to the year 1742." -Taken from the Documents now in possession of N. H. Gould, Esq.

We have noticed this institution from the fact of its having been said to be "the oldest body in the United States." It is in a flourishing condition, numbering about one hundred and fifty members."

The above caught the Masonic eye, when Brother J. L. Gould of Connecticut, cited the above in his in publication, "Guide to the Chapter," dated 1868, New York, in which he included: "a lodge organized in Rhode Island, A.D. 1658, or fifty-nine years before the revival in England, and seventy-five years before the establishment of the first lodge in Massachusetts."

Seeking the facts, Grand Master Gardner of Massachusetts, wrote to Brother N.H. Gould, Esq. who had moved to Texas. Brother Gould replied that a distant relative of his had passed away, herself a relative of a former Governor, whose estate was administered by Gould's father. In an old beaten up trunk was found some papers including a scrap of paper reading, "Ths ye (day and month oblitered) 1656 (or 8, not certain which, &c.) Wee mett att y House off Mordecai Campunnall, and after Synogog Wee gave Abm Moses the degrees of Maconrie." Gould added that the heavily worn paper along with the old papers were "nicely enveloped and packed away in his house securely, but not where he can at present put his hand upon them." His full reply can be found in the Proceedings of the Grand Lodge of Massachusetts – 1870, page 358.

Search was made of the Masons in and around Newport, Rhode Island and nothing found. Of course this story is easy to disclaim, as did

almost every Mason who scrutinized it. Masonry before the first Grand Lodge in 1717, was purely Christian in character. It would be difficult for anyone of the Jewish faith to accept the fully Christian practices. Jewish members were heartily welcomed into the Masonic Fraternity after the Grand Lodge was formed, when the new lodge system required that members be only of the Religion in which all men can agree, leaving their particular opinions to themselves.

The three degrees mentioned in the "History of Rhode Island" became just" degrees" in Gould's reply. Degrees (two) did exist in Scotland in the later part of the seventeenth century. England did not practice three degree system until after 1720. The Jewish families mentioned were from the Netherlands where they left because maltreatment. The date cannot be defined, and then we have the problem of "no original" to examine and possibly date through the type of paper or ink.

A thorough account of the above, can be found on the "Grand Lodge of British Columbia and Yukon Website: *History Index/Early Freemasonry*," but perhaps the most detailed version is established in the "*Freemasonry in Rhode Island – 1891, Memorial Volume*" published by the Grand Lodge of Rhode Island. Henry Wilson Coil in his 1961 edition "*Coil's Masonic Encyclopedia*" briefly relates the story. Both books are available at the Masonic Library Covington Scottish Rite, 1553 Madison Avenue, Covington, KY 41011. The Library is open the first and third Tuesdays (5:30pm -7:30 pm, and the first four Wednesdays (6:00 pm – 8:00 pm) each month or for a special appointment email Bill Lorenz, Librarian – library.covsr@outlook.com
