My Brethren,

As we celebrate Independence Day, the anniversary of our nation's birth, and all of the festivities the holiday brings, many of us will gather in our backyards around a bountiful barbecue. With summer in full swing, the smell of food roasting at backyard cookouts, street festivals, or other events often fills the air, drawing us in with the promise of something delicious and 'good.' The aroma is both intriguing and comforting, reminding us of the simple joys of life.

Recently, as I stepped into a lodge, I was struck by an unexpected, yet familiar scent—the fragrance of incense. While it isn't a smell I've ever particularly loved, in that moment, it stirred memories and reflections. It reminded me of the sacred halls of churches I've attended, like St. Paul's Episcopal, where incense is more than just a scent. It symbolizes prayers rising to heaven, reverence, and the divine presence.

In Freemasonry, incense plays a similarly profound role. In the Third Section of the Master Mason's Degree, we encounter the Pot of Incense, an emblem rich with meaning. It represents a pure heart—always an acceptable sacrifice to Deity. This emblem is more than mere decoration or allegory; it is a call to spiritual discipline and sincerity.

Consider the nature of incense. When lit, it glows with fervent heat, releasing a distinct fragrance that fills the room. It is consumed in the act of offering, transforming solid matter into spirit. Similarly, our hearts should burn with fervor—not for vanity, but with gratitude toward the Grand Architect of the Universe, who blesses us daily with life, health, fraternity, purpose, and peace.

The glowing incense reminds us that a pure heart is not passive. It is active, zealous, and continually rising toward the Divine. Just as incense ascends, so should our thoughts and actions. Gratitude, is not merely an occasional sentiment; it is a continual disposition of the heart, one that can transform even life's trials into opportunities for growth and refinement.

This symbolic *Pot of Incense* is central to our broader Masonic journey. As Freemasons, we are engaged in the lifelong work of transforming the rough ashlar, the unrefined stone that represents the natural man, into the perfect ashlar, fit for the builder's use. This is not a task that can be completed in a day. It requires patience, introspection, and a commitment to moral and personal improvement.

Let it remind you that, just as the glowing incense in the censer is always acceptable to the Grand Architect of the Universe, so too is our continual offering of self.

May our hearts, like that ancient emblem, glow continually with gratitude. And may our lives, like the perfect ashlar, become fit for the spiritual building, that house not made with hands, eternal in the heavens. Though the work is great, the stones heavy, and the chisel sometimes strikes hard, with time, patience, and perseverance, we will accomplish all things!



GRAND HISTORIAN'S NOTES

Brothers,

This month I have chosen to share with you the biography of our first Grand Master, Brother William Murray. Most Worshipful Brother Murray was a prominent citizen of the city of Lexington, even donating the land and building where Lexington Lodge No. 1 met for nearly a century. I hope you find it both enjoyable and informative.

William Murray was a bachelor, a very eminent lawyer, and the Attorney General of Kentucky. In prosecuting the inquiry concerning the conspiracy of Arron Burr, Murray opposed Henry Clay and John Allen (Burr's counsel), who both afterward became Grand Masters. Murray was a man among men, of great foresight, force of character, and excellent sense, who had the courage to stand alone in support of his convictions.

As Representative of Franklin County, in 1798, he opposed resolutions that were, practically speaking, nullification doctrine, holding that "the authority to determine that a law is void is lodged with the judiciary." He was the only member who spoke against the resolutions and steadily voted (generally, or six out of nine times alone) against them, and Kentucky repudiated the doctrine in later years.

Brother Murray was appointed United States Attorney for the District of Kentucky in 1791. He served as the second Attorney General of Kentucky from 1792 until 1795. During this period, he became a staunch Federalist. He served concurrently as Attorney General of Kentucky and as United States Attorney for the District of Kentucky until December 07, 1792. In a letter written to Thomas Jefferson, then the United States Secretary of State, written from Lexington on the same date, he penned the following:

Sir,

An Act of the Assembly of the Commonwealth having provided that no person shall hold an Office of under the Government of the United States, Honor, Trust, or profit under the State who holds such an Office District becomes inconsistent with that of Attorney General for the Office of Attorney for the Kentucky State. This makes it necessary that I should resign the Office with which I have been honored under the Government of the United States. I therefore beg leave to enclose my patent and to assure you that I am, with great consideration, your most obedient and humble Servant.

William Murray

Prior to his affiliation with Hiram Lodge No. 4 and subsequent Masonic activity in Frankfort, Brother Murray had been a member of Lexington Lodge No. 1 and served as its Master in 1793. On December 16, 1795, Murray and his wife Katherine deeded the property and log cabin he owned at the corner of Short and Walnut Streets in Lexington to Lexington Lodge No. 25 (now No. 1), where the lodge first met in 1788. The lodge and Grand Lodge continued to meet in buildings on the site until 1891. Brother Murray presented the address to the Grand Lodge of Virginia concerning the formation of the Grand Lodge of Kentucky, which he is believed to have written.

He died on August 09, 1805, in Natchez, Mississippi, and resolutions and a badge of mourning were adopted. Murray Lodge No. 35, the third lodge in Lexington, was organized and chartered in August 1816.

RUDYARD KIPLING AND LODGE HOPE & PERSEVERANCE

Part II of III



Though Kipling became a member of the exclusive Punjab Club like other Anglo-Indians at Lahore, his personal association with it was not a pleasant one. Being only 17 or 18, Kipling did not feel at ease with the older and experienced members of the Club and Harry Carr pointed out that he “was a none-too-popular honorary member of the Punjab Club as he was too young for full membership.” He was “told every evening of the faults of that day’s issue (*Civil and Military Gazette*) in very simple language,” mentioned Kipling in his autobiography. The only personal situation that he alluded to in his autobiography in regard to the Club was when the members had hissed at him for the *C. & M.G.*’s policy on the Ilbert Bill. Young and shy that he was, Kipling felt very embarrassed and uncomfortable.

By contrast, Lodge Hope and Perseverance No. 782 welcomed him with warmth and friendliness, even though at the time of his initiation into Masonry on April 6, 1886, he was eight months short of the minimum membership age of twenty-one. He was unanimously elected to the membership of the Lodge which had people of various faiths and professions. Within a few months he was elected to the position of an Acting Secretary which post he held till January 10, 1887 when he was unanimously elected as Secretary of the Lodge at a regular meeting. He remained its Secretary for a period of about ten months up to November 7, 1887. Kipling’s unanimous election to membership and secretaryship of Lodge Hope and Perseverance at such an early age is a testimony to his personal interest and zeal in Masonry as well as the degree of trust, confidence and goodwill of both Europeans and Asiatics that he had earned by his sincerity and devotion to the Masonic ideals.

During his secretaryship of the Lodge, Kipling got the interior decorations of the Masonic Hall done and “attended every monthly meeting up to and including August 15, 1887.” On April 4, 1887, he presented a paper on the ‘Origins of the Craft’ and three months later, on July 4, 1887, he read another paper entitled ‘Some Remarks on Popular Views of Freemasonry.’ J. J. Davies referred to these papers in his farewell address to Kipling: “Bro. Kipling has also contributed towards the welfare of the Lodge by a series of lectures which he delivered . . . of a nature both interesting and instructive . . .”

Kipling’s continued interest and enthusiasm in Masonry resulted in his unusually quick elevations in Masonic degree. Exactly four weeks after his initiation, he was passed to the Second Degree on May 3, 1886, and in another seven months’ time, on December 6, 1886, he was raised to the Sublime Degree, which is the status of a ‘Master Mason.’ At that time Kipling was still 24 days short of the minimum membership age. From the Masonic point of view, this was a remarkable accomplishment, and young Kipling was regarded as “an ornament to his lodge and a bright light in the Masonic Circle.” R. E. Harbord and Basil M. Bazley indicate that it was “an unique position” that the Minutes recording his raising were entered in his own handwriting “he having acted as Secretary to the meeting at which he was raised.” The praises and compliments that Kipling received from his Masonic friends were prior to his literary fame in India. At his farewell ceremony in the autumn of 1887 when Kipling was transferred to the Pioneer at Allahabad, J. J. Davies paid high tributes to Kipling’s Masonic activities: “Those of us who have watched his conduct since his initiation feel sure that he has before him a



successful Masonic career, for the thoroughness with which he conducted his duties was prompted by a lively interest in his work and by a keen desire for a deeper insight into the hidden truths of Masonry.” E. C. Jussawallah, an Indian Mason, recorded Kipling’s reply to Davies: “He (Kipling) said he would always remember with pride and affection the meetings he had attended at Lodge Hope and Perseverance whereby he had formed friendships which would leave a lasting impression on his memory.”

When Kipling moved to Allahabad from Lahore, he retained his full membership of his Mother-Lodge for a period of over six months as his letter of March 22, 1888, indicated. Addressed to Lodge Hope and Perseverance at Lahore, the letter was read out at the Regular Meeting of the Lodge on April 2, 1888, with F. Koenig in the chair.

Dear Sir and Worshipful Master,

It is with deep regret I have to inform you that I am now permanently transferred to Allahabad and therefore forced to abandon any active connection with my Mother Lodge . . . I have of course no intention of withdrawing my name from the Lodge Roll and shall be obliged if you would have me put down as an Absent Brother . . .

I send herewith Rs. 24 P.M. subscription and shall always look back with keen pleasure to my Masonic life in ‘Lodge Hope and Perseverance’ and, if at any time, I can do anything to further its aims and objects, am entirely at your disposal. Convey my warmest and most fraternal regards to the Brethren and

Believe me

Yours faithfully and fraternally

(sgd.) Rudyard Kipling

According to his wish, Kipling was recorded as an ‘Absent Brother’ in the register of the Lodge. In November, 1929, he presented to his Mother-Lodge a Gavel composed of stone from the quarries from which was obtained the material for the building of King Solomon’s Temple at Jerusalem. It bore the inscription: Presented to Lodge Hope and Perseverance by Bro. Rudyard Kipling. In 1935, Kipling was elected an Honorary Member of the Lodge as recorded in a Circular of the Regular Meeting held on May 7 of the year. In recognition of his life-long attachment to and love for his Mother-Lodge, Lodge Hope and Perseverance was given the subsidiary title of ‘The Kipling’s Lodge’ in December of 1936, eleven months after his death. It was an act of signal honor that Lodge Hope and Perseverance showered on its youngest secretary and one of its most devoted Masons.

In addition to his Mother-Lodge, Kipling was also associated with Fidelity Mark Lodge No. 98, Mt. Ararat Ark Mariners’ Lodge and St. John the Evangelist at Mian Mir. According to Albert Frost, Kipling was “advanced in the Mark Degree in Fidelity Mark Lodge No. 98 at Lahore, on 14th April, 1887, and was elevated in Mt. Ararat Ark Mariners’ Lodge on the same day.” Kipling used to visit the Lodge at Mian Mir which consisted mainly of military personnel. “Amongst the Members of that Lodge at this time were Surgeon Terence Mulvaney of the Army Medical Department and Lieut. Learoyd of the Royal Artillery, both men he (Kipling) must have met and from whom he may have borrowed the names he made so widely known” in *Soldiers’ Three*. (To Be Continued)

HENRY PIRTLE – KENTUCKY’S FORGOTTEN FAVORITE SON PART II

Kentucky Monitor: Henry Pirtle was not an author of ritual, and it should be noted that he never claimed to be. What he was, was a careful and conscientious compiler and arranger of ritual. Relying on the Preston-Webb work already in use throughout American Freemasonry at the time, Pirtle delivered a monitor that included complete ceremonies for the opening and closing of Lodges on each of the Three Degrees, along with funeral and burial services. He also included detailed lectures for each of the Three Degrees of Freemasonry. His lectures were closely related to the tracing board developed and marketed by 19th Century Ohio Freemason John Sherer. The Pirtle lectures could (and still can be) delivered harmoniously with the Sherer tracing boards.

The opening and closing charges that Pirtle included in his *Monitor*, while largely overlooked, represent a succinct and completely clear expression of the ultimate purpose of Freemasonry.

To say that the *Kentucky Monitor* received a lukewarm reception from the Grand Lodge of Kentucky is an understatement. Pirtle presented the *Monitor* to the Grand Lodge in 1920. It was referred to committee on several occasions, and in each instance, the Grand Lodge declined to formally act on the *Monitor*. Although the *Monitor* quickly gained popularity among the Craft, it took an amazing 32 years before it was formally accepted by the Grand Lodge of Kentucky. Not until 1952 was the *Kentucky Monitor* officially recognized by the Grand Lodge of Kentucky as an acceptable ritual guide.

Although he was surely disappointed by the unenthusiastic reception given the *Kentucky Monitor* by the leadership of the Grand Lodge of Kentucky, fate was about to intervene in Henry Pirtle’s life in a profound way. In 1919, Pirtle accepted a position with Cleveland Trust Company, and he and his wife, Blanche, moved to Ohio. W. B. Pirtle settled in the suburb of Cleveland Heights, where he would later serve as a city councilman, and, eventually, as mayor of Cleveland Heights. He continued with Cleveland Trust Company until his retirement, at which time he was the Bank’s Vice-President in charge of corporate Trusts.

Following W. B. Pirtle’s move to Ohio, he demitted from Louisville Lodge No. 400 on January 17, 1921. He affiliated with Lion Heart Lodge No. 673 later in 1921. There are no available records to indicate the extent to which, if any, he was involved in the leadership of that Lodge.

Perhaps feeling the pull of his mother Lodge, he reaffiliated with Abraham Lodge No. 8 on April 16, 1930. Again, there are no records that indicate that, other than maintaining his membership from afar, he was ever involved in the activities of the Lodge.

His official inactivity notwithstanding, Henry Pirtle never lost his interest in Freemasonry, nor did he ever lose his passion for the inquiry into Masonic symbolism and philosophy. In 1951, he published his final work, *The Lost Word of Freemasonry*. Both brilliant and brilliantly written, Pirtle uses *The Lost Word* to describe Freemasonry as a quest. Pirtle asserts that the

quest of the Freemason is the quest of the soul after God.

Unfortunately, copies of *The Lost Word* of Freemasonry are extremely difficult to find, and reprints are unreliable, at best. Pirtle’s final work, the *Lost Word of Freemasonry*, should be far better known than it is. At the very least, it gives us one last glimpse into the mind of a man for whom Freemasonry was personal, and to whom the spirit of Freemasonry was a living thing.

Henry Pirtle died in on June 4, 1955. Incredibly, there was no notice of his death in “The Masonic Home Journal.” A mere one sentence appears in the Grand Lodge proceedings noting his death. W. B. Henry Pirtle deserved better from his Kentucky Brethren.

His work has survived the test of time. Early editions of *The Kentucky Monitor* included an essay that Pirtle wrote titled “The Spirit of Masonry.” No writing anywhere better serves to present the ultimate lesson of Freemasonry, than does Pirtle, when he says that, “It is for each individual Mason to discover the secret of Masonry, by reflection upon its symbols and a wise consideration and analysis of what is said and done in the work.”

Henry Pirtle’s work lives on, fresh and timeless. It would be well if Kentucky Masons knew him better.




