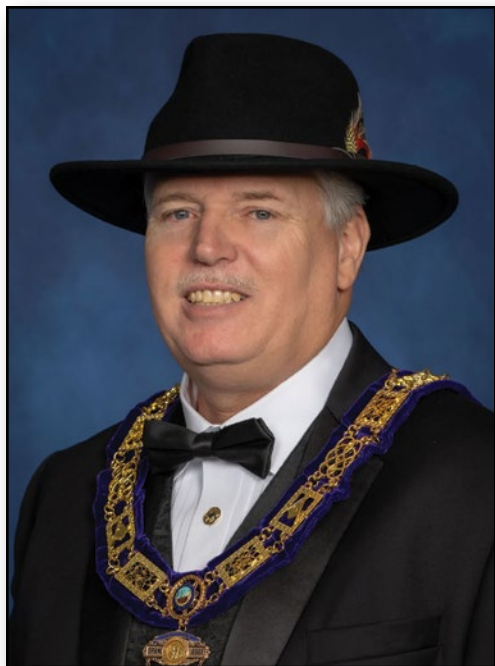

GRAND HISTORIAN'S NOTES

ONLY THE BEGINNING

On June 4, 1775, a group of frontiersmen were camped at McConnell Springs in the wilds of Kentuckee. They heard the news of the Battle of Lexington and named their campsite Lexington. This was the first city named in honor of the site where the American Revolution began.

The Grand Lodge of Virginia established the first Masonic lodges west of the Alleghenies. First was Lexington #25, on November 7, 1788, four years before Kentucky became a state. It was followed by Paris #35, December 6, 1791; Georgetown #46, November 29, 1796; Frankfort-Hiram #57, December 17, 1798 and Abraham's Lodge U.D, July 10, 1800.

The first "Masons Hall" was a small log house of primitive style built on lot No. 21, in the town of Lexington, donated to Lexington Lodge #25 by Brother William Murray, afterward the first Grand Master of Kentucky, and Katherine, his wife, to James Morrison, Edmund Bullock, Robert Megowan, Hugh McIlvain and Alexander McGregor, as trustees of "Lexington Lodge of Ancient Free Masons".

At the invitation of Lexington No. #25, a Convention of Delegates from the several Lodges in the State of Kentucky met in "Mason's Hall" on September 8, 1800, in the town of Lexington. The 5 lodges were represented by 15 masons. Brother John Hawkins, of Georgetown #35, was elected Chairman and Brother Thomas Bodley, of Lexington #25, was elected clerk. *(There is a diploma in the Grand Lodge of Kentucky Library and Museum showing that "Brother Thomas Bodley was initiated, passed and raised to the sublime degree of a Master Mason and had served the last six months as presiding Master of this lodge". It is dated October 10, 1799 and was issued by Lexington #25. This diploma and two others were presented to the Grand Lodge Museum in 1912. Brother Bodley served as the 13th Grand Master of the Grand Lodge of Kentucky).*

The convention proceeded to business and passed the following:

1. that the representatives of each lodge shall have one vote and the Past Masters, who are not representatives, one vote
 2. that it is expedient, necessary, and agreeable to the Masonic Constitution that a Grand Lodge should be established
 3. that the several lodges now represented be requested to appear by their Representatives, at this place on Thursday, the 16th of next October for the purpose of opening a Grand Lodge
 4. a committee of five were appointed to draft a respectful address to the Grand Lodge of Virginia giving the reasons these lodges to separate from its jurisdiction
 5. that every lodge to pay up all contributions due to the Grand Lodge of Virginia prior to the time of establishing a Grand Lodge of Kentucky.
- The convention then adjourned until the next morning at 9 o'clock.

The reason leading up to the separation was the distance. Over 700 miles separated the masons of Kentucky and the Grand Lodge of Virginia. Traveling an average of 25 miles per day, not counting rest stops, it would take 28 days to reach Richmond VA from Lexington KY. Knowing that the charity fund was an important object in the Masonic institution, this benefit could not be extended to any brother or family in Kentucky. This distance also gave hardships to the Grand Master of Virginia or

visitors attending lodges and those appointed to inspect the work. Also, the distance frequently prevented the lodges in Kentucky from being represented in the Grand Lodge of Virginia.

In consequence of the third resolution of the convention, representatives of the five lodges assembled again on Thursday, October 16, 1800, for the purpose of opening a Grand Lodge for the State of Kentucky. The Worshipful James Morrison, being the oldest Past Master present was requested to take the chair. He proceeded to appoint the following: William Murray, Senior Warden; Thomas Hughes, Junior Warden; Thomas Bodley, Secretary; James Bliss, Treasurer; Isaac E. Gano, Senior Deacon; John Bobbs, Junior Deacon and Nathaniel Barker, Tyler. A Master Mason's Lodge being opened in due form, the Lodge proceeded to the election of Grand Officers. Worshipful Brother William Murray was unanimously elected Grand Master and was installed according to ancient form. Worshipful Simon Adams was elected Grand Senior Warden and Worshipful Cary L. Clarke, Grand Junior Warden. Both were respectively installed according to ancient form. The following Grand Officers were then elected: James Russell, Grand Secretary; John A. Seitz, Grand Treasurer; Thomas Hughes, Senior Grand Deacon; Nathaniel Williams, Junior Grand Deacon; Samuel Shepherd, Grand Pursuivant and John Bobbs, Grand Tyler. All were presented to the Most Worshipful Grand Master and installed according to ancient form.

Simon Adams, William Sutton and Isaac E. Gano were appointed to prepare a circular to other Grand Lodges detailing the reasons for withdrawing from the Grand Lodge of Virginia. This circular is a part of the 1800 Grand Lodge of Kentucky Proceedings.

The Grand Lodge of Virginia *Ahiman Rezon*, with subsequent amendments, was to govern the Grand Lodge of Kentucky and subordinate Kentucky lodges until the Grand Lodge of Kentucky published its own *Ahiman Rezon*. *(On March 30, 1808, the Masonic Constitutions or Illustrations of Masonry was approved. It was written by Brothers James Moore and Cary L. Clark. It was printed by Daniel Bradford at the office of the Kentucky Gazette in Lexington, KY and 500 copies were ordered at a cost not to exceed \$150 (\$3,845.18 in 2025 dollars.). The Grand Secretary was ordered to sell them to lodges for \$1.25 per copy and to send a copy to each Grand lodge in correspondence with the Grand Lodge of Kentucky. I know of 7 of the original 500 printed in existence. There could be more lying on someone's bookshelf waiting to be "discovered".)*

It was the unanimous opinion of the committee that the Most Worshipful Grand Master ought to appoint some well-skilled brother or brothers to visit and inspect the workings of the different Lodges under the jurisdiction of this Grand Lodge.

The lodges were listed as Lexington #1, Paris #2, Georgetown #3, Hiram #4 and Solomon's #5.

The seal of Lexington Lodge No. 25 was to be used as the Grand Lodge seal until one could be prepared. The seal of Lexington Lodge No. 25 contained the usual square and compass, minus the letter "G", but with the sun and moon on either side. *(The letter "G" did not appear in the square and compass until the mid-1800s.)*

The lodge charters were to be "delivered up" and new temporary charters were to be furnished to lodges Nos. 1, 2, 3 and 4 for £5 each and to No. 5

for £10 (£30 = \$4,341.36, in 2025 dollars). The lodges would be credited for these amounts on paying the Grand Secretary's fees in advance.

The newly formed Grand Lodge, not having a seal, parchment or vellum proper for making proper charters, it was recommended that the Grand Secretary prepare a charter for each lodge represented in the Grand Lodge, which would be signed by the Grand Master and attested by the Grand Secretary under the seal recommended. The completion of the seal for the Grand Lodge would be left with the Grand Secretary.

The Right Worshipful Deputy Grand Master, the Grand Secretary and the Grand Treasurer constituted a committee to prepare the regalia, tools, jewels and other necessary apparatus for this Grand Lodge and the livery to be crimson.

With all the questions having been put of each of the resolutions, the whole was ratified and confirmed. It was ordered that the Grand Lodge be adjourned until the 2nd Monday (9th) in February 1801 or during the pleasure of the Most Worshipful Grand Master.

Thus, the first Grand Communication of the Grand Lodge of Kentucky came to a close.

On December 11, 1800, the Grand Lodge of Virginia communicated Resolutions to the Grand Lodge of Kentucky their willingness to cooperate with the establishment of the Grand Lodge of Kentucky.

It was only the beginning.....

"I Didn't Know That....."

BOOK REVIEW: "MEN OF GOOD TIMBER: 21ST CENTURY ESSAYS & RESEARCH ON PURPOSE, PROGRESS AND MASONIC IDEALS" AUTHORED BY JOHN W. BIZZACK WITH DAN M. KEMBLE

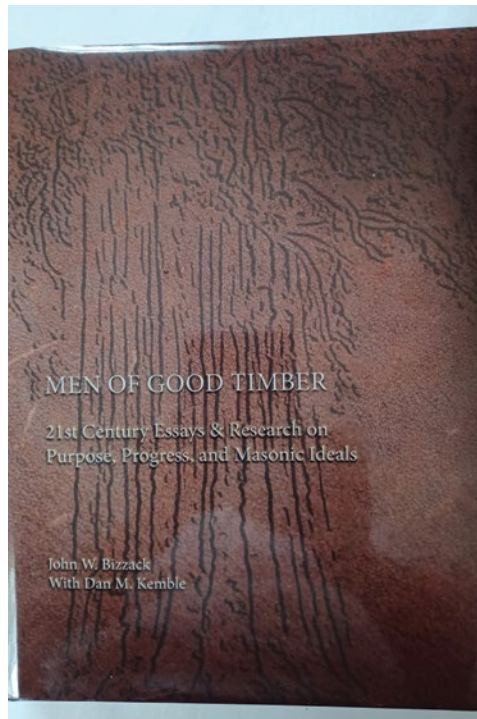
Just a few days ago the postman dropped off in the mailbox, an advance copy of *"Men of Good Timber: 21st Century Essays & Research on Purpose, Progress and Masonic Ideals"* co-authored by John W. Bizzack and Dan M. Kemble. Both Bizzack and Kemble are well known for their exhaustive exploration and comprehensive analysis on Masonic subjects, not only in Kentucky but on a national level as well. John Bizzack has written a number of quality books that have been well received by the Craft and Masonic scholars inside and outside of the United States. Although Dan Kemble is perhaps best known for his broad-based research papers that he has presented to Research Lodges around the country, he has also contributed to many Masonic publications. The 'flavor' of his writing is always well received.

The book takes its name from a poem written in 1922 by Dan Malluck called "Good Timber."

The poem describes the life of an ordinary small tree. One verse sums the poem; *'Good Timber does not grow with ease, The stronger the wind the stronger the trees, The further the sky the greater the length, The more the storm the greater the strength, By sun and cold by rain and snow, In trees and men good timbers grow.'* The two authors collaborated to include in the book a short article of their views on 'good timber, freemasonry and society.'

What do I really like about the "Men of Good Timber? First the easy-to-hold 8¾ x 11¼ book size, jam packed with a spectrum of Masonic topics on 324 pages. Besides the standard Index, there is an overview or one paragraph summary of the contents on each topic, so one can readily pick and choose his desired interest. Most subject matter is limited to five to eight pages, with some as few as one or two pages, while the story of the William Morgan abduction, and the results pertaining to it, consumes twenty-six pages. However, the Morgan theme is broken into four parts plus the conclusion and adds two book reports on previous written material, to fill twenty-six pages. The Morgan theme, presented in parts, allows the busy Mason to read a portion as time allows, set it down and pick up where he left off without breaking thought, the shorter topics also.

My problem is that it is difficult to put the book down! It is a fascinating book covering so many subjects of Masonic interest. I find myself indulging late in the evening, particularly appreciating when the authors



present opposing sides to a subject. This allows the reader to think for himself and come to his own conclusion.

"Men of Good Timber" includes essays on several famous books and movies, including: *"The Man Who Would Be King"* (Rudyard Kipling), *"War and Peace"* (Leo Tolstoy), and the Western film, *"High Noon"* and their relation to Freemasonry. Book reviews include: *"As a Man Thinketh"* (James Allen), *"Doings of the Grand Lodge of Kentucky – 1800-1900"* (H.B. Grant), *"The Masonic World of Ray Denslow"* (Missouri Lodge of Research), *"Fiat Lux Volume I"* (Philalethes Society), *"Speculative Masonry"* (Andrew MacBride), *"The Men's House"* (Joseph Fort Newton) and *"A Short History of Masonry to 1730"* (Douglas Knoop/G.P. Jones). All of these books are worthwhile reading.

Subjects also included in the collection of essays are: myths to 'working jackets', Masonic antiquarians to cranks, popular authors and little known authors who have written important works, a lecture on 'well done is better than well said' a nice biography on Kentucky's Henry Pirtle, Rev. Joseph Fort Newton's contributions, moral character and changing demographics in Freemasonry, to name a few.

Many questions are asked of the reader to ponder; "What is Freemasonry? What does Freemasonry mean to me? What do I mean to Freemasonry? If everyone in my lodge was just like me, what kind of lodge would it be? What are we passing on?"

"Men of Good Timber" has nearly 50 topics of interest to masons of all degrees. Room in this article does not allow comments. The book is well written and well researched. I really enjoyed *"Men of Good Timber"* by these two Kentucky authors and you will too. The book is available at the Covington Masonic Library.

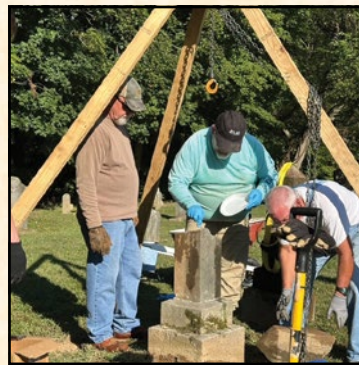
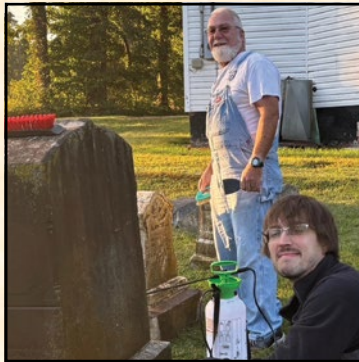
