As Masons we should reflect on the teachings, work and purpose of our Craft on an ongoing basis, if we are to be true “seekers of Light.” Every Masonic body considers the state of its membership – how to retain, maintain and grow it. I firmly believe in a “first things first” approach, that by doing so we will remain vital, and attract good men to join with us “in this great and good work.”

First, foremost and always let us focus on our Masonic teachings - making our gatherings purposeful, instructive, enjoyable and uplifting. If we ourselves are uplifted and enthused, it will be noticed by our family, friends and acquaintances – and good men will be attracted and want to participate.

Recall when you yourself became a Mason. Did you ponder the significance of your Masonic initiation? Did you consider it just the joining of a club through a quaint, if not antiquated, ceremony, or the beginning of a journey that was ongoing?

What is initiation? There are two common definitions:

in·i·ti·a·tion noun: initiation

- 1. The action of admitting someone into a secret or obscure society or group, typically with a ritual.**
- 2. The action of beginning something.**

Synonyms include: beginning – starting – commencement.

Personally, I look at Masonic Initiation not as a “completion” – it is not just something bought in a packaged deal – like membership into a club.

Isn't it really a beginning, a commencement, a starting of a personal journey experienced within a group of like-minded good men? What has begun? Investigating our self, learning our true nature? Learning how to live a meaningful life? Who has started it? You, the Individual - you made the request of your own free will & accord. For what purpose? Individual rebirth – emergence from darkness to light. One cannot purchase this with an initiation fee or annual dues – it requires individual work and effort – for there can be no change without effort and discipline.

What did you join? A group of like-minded men, who turned out to be brothers – a brotherhood of man, under the Fatherhood of God. Where is this work done? It is both Internal – personal study and reflection; and External - group practice – that is, our meetings and ritual, during which there is acknowledgement of the Supreme Being, and an inviting and welcoming of the Spirit through our joint acknowledgement of Divine relationship. In this experience there is a transformation from the isolated self to the enlightened Self.

HOW GOOD & PLEASANT IT IS FOR BRETHREN TO DWELL TOGETHER IN UNITY; UNITE WITH US IN THIS GREAT & GOOD WORK

Masonic principles require both – internal, personal study and effort, as well as the group experience through ritual, education and social relationships. Without either of these, in balance, the “formula” falls apart.

But it always must begin with the Individual – the earnest Seeker of Light and Truth.

Why then should a Mason join the Scottish Rite? What then we do have to offer in the Scottish Rite?

Well, if we have begun at the beginning, laid our foundation stone in its proper place, and heeded the lessons inculcated, then it should be clearly seen that the Scottish Rite serves to assist the earnest seeker on his continuing journey to enlightenment, through its deep and instructive ritual and spiritual observances, within a brotherhood of supportive, like-minded men, enriched by a deep social bond.

But the Mason without guile, as we are called to be in the 14th Degree, would see that before we can ask a Mason to join the Scottish Rite we must have answered the question for ourselves – why did we join?

If we have looked within and can answer the question clearly, simply and without guile, then it will be manifest on our countenance and will be felt and seen by our fellow Masons. And it may well be that we won't have to ask him to join – he will feel the Spirit and will be prompted to ask us!

First things First.

THE OLDEST RING?

Roland T. Stayton, 33°

In "Why Thirty-Three?" (Heredom, Vol.1), Ill. S. Brent Morris, 33°, asked "Where is the oldest Thirty-Third Degree ring located?" It may be in Louisville!

In 1844, Frederic Webber, age 16, came to America with his parents and settled in Louisville, Kentucky. He became a Mason on his 21st birthday. By 1852 Bro. Webber was a prominent Symbolic and York Rite Mason and became a charter member of the Grand Consistory of Kentucky in Louisville.

In 1858 he was Sovereign Grand Inspector General, 33° in Kentucky. By 1859 Ill. Bro. Webber became Treasurer General of the Supreme Council, then later Secretary-General, serving the Supreme Council for a total of 48 years 7 months, the longest tenure in that body by anyone. He died in 1907. He was succeeded as S.G.I.G. by Ill. Bro. John H. Cowles, 33°, who was Grand Commander from 1921 until 1952. Two active S.G.I.G.'s for a one hundred year period!

On August 14, 1930, the cornerstone for the new Scottish Rite Temple in Louisville was laid with full Masonic ceremonies. In that cornerstone was placed the Thirty-Third Degree ring of Ill. Bro. Webber. Indeed a "Memorial that was placed in the Archives!" Can you top this?

"I Didn't Know That....."

The Honorable Mrs. Aldworth, became known as the first lady freemason, supposedly initiated in a Masonic meeting at her father's, (Lord Donerail) manor near Cork Ireland. As a young and curious girl, she removed a brick from a recently reconstructed wall, and peered into the room where the lodge was held, supposedly listening to and watching the first two degrees. Accidentally making some noise, she was discovered and the brethren decided after long discussion, to initiate her to keep secret the ceremonies of the lodge. All this took place (circa 1711) before the premier Grand Lodge in London was formed in 1717 and the 1723 Constitutions. An Irish poem, somewhat humorous, made the event famous.

Later, marrying Richard Aldworth, her portrait was painted in full Masonic regalia, and in a masonic posture, with masonic symbols in the background. Her jewels and regalia are preserved by the family as heirlooms. Her name along with her masonic titles is listed as a subscriber to Fifield Dassigny's book, "A Serious and Impartial Inquiry into the Cause of the Present Decay of Freemasonry in the Kingdom of Ireland". What do you think?
