What is Missing From Freemasonry?

“In my Lodge, we only dress up for important meetings!” These words were spoken in defiant explanation as to why a Kentucky Freemason refused to wear a suit and tie to Lodge. While this may accurately reflect the thinking of many Masons, the statement immediately begs the question, “Why aren’t all Lodge meetings important?”

Freemasonry’s ritualistic ceremonies distinguish our Craft from the various civic organizations that exist alongside it. Our opening and closing ceremonies have a specific purpose. The ritual is the vehicle through which we transition ourselves from the profane world into the sacred. The opening ceremony is the final step in preparing our hearts and minds for our communion as Brothers. It is also the process by which we transform our ordinary meeting spaces into holy ground, where the Grand Architect of the Universe is present with us. Failing to recognize the importance of our ceremonies and what they represent has led to far more serious omissions in Freemasonry than mere inappropriate attire.

Theoretically, transitions and transformations occur every time we open and close our Lodges. It seems, however, that we have grown desensitized to their meaning. Because we see the ritual performed routinely, we have come to take it for granted. We should, however, constantly remind ourselves that the act of opening a Masonic Lodge invokes the divine power of the universe – an act that should be neither ignored nor taken lightly.

Do we expect to see changes in the lives of men as a result of their involvement in Freemasonry? It’s hard to justify such an expectation if we routinely disregard the spiritual force in our Lodges that can effect such change.

The fact that we no longer view our Lodge meetings as important events says far more about us than it does about Freemasonry. It is a jarring indicator that, as Freemasons, we fail to understand one of the most fundamental aspects of our Fraternity. A communication of a Masonic Lodge is more than just a business meeting. Its purpose is wholistic in nature and, in part, is intended to address the spiritual aspects of man’s being.

As Freemasons, we like to say that we “make good men better.” Indeed, the purpose of Freemasonry is to bring about a transformation in the life of a man, taking him from his rude, imperfect state and rendering him, whole and complete, a living stone worthy of the spiritual temple. If we, as Freemasons, do not recognize (and teach) the importance of the transformation that occurs in our Lodges, what is the likelihood that we will be able to equip men with the skills necessary to bring about the personal transformation that they seek?

We do our ritual a disservice by treating it as routine. It is not routine, and was never intended to be. By failing to fully invest ourselves in its meaning and its power, we experience only a shadow of Freemasonry’s tremendous promise. The absence of our appreciation for the genuine meaning and importance of our ceremonies, and, correspondingly, the way we fail to apply those teachings in the lives of men, explains, at least in part, the membership freefall that we have experienced over the last sixty years.

The men who made up the five Lodges that met to form the Grand Lodge of Kentucky were not casual in their approach to Freemasonry. That should come as no surprise. The conditions of the era in which they lived hardly allowed them to be casual about anything. But even as they engaged in a daily struggle to survive in an isolated and undeveloped country, they believed that Freemasonry was important enough to deserve the investment of their time and attention. Simply put, these men believed in the promise of Freemasonry and they wanted its influence in their lives. To them, Freemasonry was important enough to sacrifice their precious time and resources to ensure its continued presence in their midst.

In the centuries that have passed since the inception of our Grand Lodge, we have, in the main, lost the fervor that the founders possessed. What have we lost that the founders so clearly possessed?

The answer can be found, at least in part, in two factors. First, we have come to almost completely ignore the spiritual element of Freemasonry. We do not contemplate upon, or even recognize, the intended purpose of our ceremonies.

The spiritual element of Freemasonry, of course, does not belong specifically to one religion. The power of Freemasonry is revealed in the fact that the Lodge is a place where men of all faiths and creeds can unite in the presence of the Grand Architect of the Universe in a spirit of fraternal good will. But to capture the promise of Freemasonry – that spirit of good will – it is necessary to first realize that it is the sacred space created through our ritual that provides the environment in which that spirit may exist and be found.

The second missing factor is the extent of our individual spiritual investment in Freemasonry. We have Brothers who are willing to invest their time. We have some Brothers who are willing to invest in Freemasonry financially. But we have very few Brothers who have invested in Freemasonry at the spiritual level. Again, this should come as no surprise. Who invests in something that they ignore or do not understand? The institution of Freemasonry and the individual Freemason, however, has suffered greatly as a result of that lack of investment.

The absence of spiritual investment is manifested in this manner: we are, largely, Masons of convenience. Our commitment to Freemasonry can be measured by the extent to which we are not inconvenienced by it. When inconveniences are added, such as increased dues, dress requirements, or attendance requirements, our commitment to Freemasonry falters.

At the end of the day, the gigantic issue that confronts Freemasonry is how to equip individual Freemasons with the understanding that every meeting of their Lodge is an important event and an opportunity to come to a closer understanding of their Creator. The spiritual force of Freemasonry is the element that is missing in contemporary Freemasonry and if that element is ever successfully addressed all of the other issues that confront Freemasonry will quickly fall into place.



VALLEY OF MADISONVILLE



Brethren,

I would like to share with you some history of the West Kentucky Scottish Rite and its Consistory.

On February 1, 1963 letters temporary were issued for a Council of Kadosh and a Consistory for West Kentucky. In March of 1963 the first class to go from 4^o-32^o received their work in Madisonville. On October 24, 1963, all of the bodies of West Kentucky Consistory received their charters from The Supreme Council of A.A.S.R., SJ.

The driving force behind the development of a consistory in Western Kentucky was Ill. Luther Smith, 33^o, Sovereign Grand Commander of the A.A.S.R., SJ. Brother Smith desired that Kentucky have a third consistory and that it not be located on water especially the Ohio River. Brother Smith communicated his thoughts to the then Deputy of the Supreme Council in Kentucky, the Ill. Charles J. Weber, 33^o of the Grand Consistory of Kentucky.

In response to the desires of Brother Smith a meeting was held in Hopkinsville, Kentucky by Brother Weber in December 1961. The exact date and the roster of those in attendance were not recorded, but a partial list has been constructed from the memories of some of the participants:

Ill. Charles J. Weber, 33^o, Louisville, KY / Obadiah Fields, 33, P.G.M., Dan Littleton, George R. Effinger all from Paducah, KY / Ill. G.L. Utley, 33^o, Henderson, KY / Robert B. Sapirsly, Hopkinsville, KY / Earl Adams, 32^oKCCH, P.G.M. Owensboro, KY / John Roy McDowell, Princeton, KY / David Parrish, & R.L. O'Bryan, Madisonville, KY.

This meeting resulted in the following decisions:

1. Letters Temporary would be requested at once for a Lodge of Perfection and a Charter of Rose Croix, the other bodies would be sought later.
2. The Consistory would be located in Madisonville, Kentucky.
3. No jurisdiction area was established but we could not organized clubs east of a line from Hancock County to Logan County.
4. Brother Weber appointed Ill. EJ. Schickli, 33^o of the Grand Consistory of Kentucky as the director of the development of the consistory. Brother Schickli was ably assisted by Brother Ralph Pryor, 32^oKCCH of Paducah, Kentucky. Brother Schickli was empowered by Brother Weber to take such actions as would be necessary to get the Scottish Rite operating in Western Kentucky.

On February 22, 1962 Ill. Brother Smith issued Letters Temporary for the Lodge of Perfection and the Chapter of Rose Croix.

On March 3, 1962 the first class of candidates was initiated. A group of ritualists from the Grand Consistory came and conferred the work in the Lodge of Perfection. A week later the work of the Chapter of Rose Croix was conferred. The candidates were then invited to the Grand Consistory to complete their work. This procedure was repeated in the fall of 1962 the ritualists from the Grand Consistory were gradually replaced by members of the West Kentucky

Bodies. In March 1964 the reunion was highlighted by the visit of Ill. Luther Smith, 33^o, S.G.C. of the A.A.S.R., SJ. Brother Smith was able to see that his dream of a Consistory in Western Kentucky had been realized.

A History of the Consistory could not be written without a special tribute to Ill. Ralph Pryor, 33^o of Paducah. Brother Pryor was the strong right arm of Brother Schickli in getting the consistory started. Brother Pryor devoted an untold number of hours of his time to working on the stage, robe room, ritual work, and etc. His efforts provided the glue that held this consistory together during its early days.

On June 6 1970 the Consistory had its largest class. A total of 215 candidates become Master of the Royal Secret.

The government of all Scottish Rite bodies was changed by Ill. Henry Calusen, Sovereign Grand Commander in the 1970s. The old system of representatives of the S.G.I.G. was replaced with a Chairman of the Sovereign Grand Inspector the General's Advisory committee. Brother Effinger appointed Ill. Wayne J. Betts, 33^o of Madisonville to that post in 1974. Brother Betts rendered outstanding service to the consistory. The building we now occupy was his "Baby" and he steered it through conception, childbirth and infancy. He, like all new "fathers", had many headaches, but he survived them. Brother Betts served in this capacity until March 8, 1989.

From February 1962 through December 1985 West Kentucky Scottish Rite Bodies leased space from Rizpah Shrine Temple. On May 24, 1985 The West Kentucky Scottish Rite bodies purchased our present building from the former Life Temple church. In 1986 renovations began. The addition of the dining room and extra storage for the stage made this building a complete Scottish Rite facility. Renovations have continued and are ongoing. Since 2004 the Lobby area, Three Offices, Dining Room Sound Room and our Childhood Language Development Center have all been renovated. On October 5, 1986 West Kentucky Consistory, located at 667 Park Avenue, Madisonville, Kentucky was dedicated by S.G.C. Ill. C. Fred Kleinknecht, 33^o, P.G.M. and S.G.I.G. Ill. George R. Effinger, 33^o.

“I Didn’t Know That.....”

When the Grand Lodge of London was formed by four old lodges in 1717 many other old lodges in the London/Westminster area and more especially those outside of London, saw no reason to affiliate with the new Grand Lodge. Fortunately for the Grand Lodge, by 1721 they elected the Duke of Montagu, with newspapers reporting 300 in attendance at his installation. With that kind of publicity, and a noble, heading the new Grand Lodge, many of the independent lodges, but not all, began to affiliate. As the London Grand Lodge grew stronger, it passed rules that members under their jurisdiction should not visit the unwarranted lodges, but masons in those days considered themselves members of the whole Fraternity, free to visit any lodge and saw no reason not to visit lodges they had in the past. There was little a Grand Lodge could do to prevent this from happening. Scant records do exist of such visits in both lodge and Grand Lodge records, but most unwarranted lodges did not preserve their records, and when the lodge failed, it was as if they had never existed.

As Grand Lodge masonry spread to other shores, resistance to be organized and governed was held by some lodges. This was particularly true in Ireland. Masonry had come early to Ireland. One of the oldest Masonic artifacts in the world, the Baal’s Bridge Square found under the foundation stone of the old bridge near Limerick reveals. It is inscribed “I will strive to live with love and care, upon the level and by the square - 1507”. Other evidence of early Irish masonry includes the reference to a Masonic Lodge with members of a variety of occupations in a speech given in 1688 at Trinity College in Dublin, and of course the story of the “Lady Freemason” Elizabeth St. Leger which occurred before Irish Grand Lodge Masonry. It is unknown when the Irish Grand Lodge was formed, but it was in existence in 1725.

Numerous records preserved in the Grand Lodge of Ireland and lodge histories, describe interaction with “un-affiliated” or “hedge” masons. This Irish derogatory term appears to have come from its previous usage as “hedge-schoolmaster”; or one who secretly taught Catholic and Presbyterian children, or those not of the Anglican faith. According to Masonic scholars Leper and Crossle, in 1740 those lodges which had not already received warrants were encouraged to do so. Leper and Crossle surmised that these unaffiliated or “hedge” masons appear to have been dominate in Northern Ireland, as Ulster had no ‘regular’ lodges until the warrant of Belfast Lodge was issued in 1748. However, hedge masonry was not limited to Northern Ireland.

In his book “Freemasons in Ulster, 1733-1813”, author Petri Mirala noted “some Ulster lodges do preserve a tradition that their Masonic ‘ancestors’ are originally hedge masons.” He went on to say “In practice, the line between “regular” and “clandestine” freemasonry could be drawn in the sand.”

Many lodges after receiving their warrant would continue to visit lodges with ‘no warrant’; some lodges would lend another lodge their warrant if needed for degree work; warrants could be bought and sold; and initiation ceremonies outside a lodge designated area, could be conducted by a mason for cash in his pocket. Despite objections from the Grand Lodge, lodges adopted their own rules. The Grand Lodge issued several regulations banning the above, with limited success. However the clandestine mason wishing to be regular, could pass through the ceremonies again, and a hedgemason lodge, could, if desired, obtain a warrant. Possibly this is reflected in Grand Lodge membership in Ulster, growing from 12,000 – 14000 in 1792, to 20,000 in 1800.

Unfortunately, the political climate in Ireland around 1790, led to division among all Irishmen: reformers and conservatives, radicals and loyalists, Protestants and Catholics. Sadly, this was also true in both regular and hedge masonry. Hedge masonry seemed to be in all sides during “Rebellion of 1798”, which placed both Presbyterians and Catholics against the English laws that were put upon them. The Defenders, mostly from farming communities and generally Catholic by faith, was originally organized to help their poor state of affairs, but later became a ‘secret’ Catholic organization, forming in ‘lodges’ and requiring ceremonies and an oath for new members. They would go on to show strong support for the United Irishmen and distaste for loyalists and Orangeism (named for King William of Orange). One Defender denounced “Orange Men and Regular Masons”, implying he was perhaps a hedgemason. Although one Royal agent complained that ‘every hedgemason in his area are United Irishmen’, a regular Masonic Lodge formed an alliance with some clandestine masons (100 and upward) to denounce the Defenders and declare loyalty to George III. Mirala notes: “In fact, it is plausible to regard (both) Defenderism and Orangeism as forms of hedgemasonry.”

The relaxing of some English laws against Catholics was perceived as a ‘Catholic threat’ by some and several secret organizations were formed. Among them, the Loyal Union of Orange, who aspired to uphold the principals of the Boyne Society and the Masons. However the Boyne Society, named for the Battle of Boyne, accepted members from all faiths, as did the Masons, but the Orange Order wanted only Protestant loyalists, and publically became thought of incorrectly as “Protestant Masonry”. They organized into lodges, conferred Masonic style degrees, and held parades. The adoption of the edited Masonic rituals, lead to denunciation by regular Masons. The Orange Order quickly moved to claim they had no relationship with Freemasonry, and attempted to separate itself completely by simplifying their ritual, and eliminating some ‘high’ degrees, and publically declaring that they were absolutely no part of the Masonic Order.

Adding to the condemnation of the Orange Order by Freemasons, was in that Orangemen would do things to harass the

Catholic community, and then gloatingly parade about the streets, enticing the Catholic community into fights. What was once fisticuffs, became killings and house-burnings. The public, thinking erroneously the Orange Order was a form of 'Protestant Freemasonry', caused much alarm among the Freemasons, however the fact that both regular and hedgemasons assisted in the forming the Orange Order as well as the Defenders, is a given.

The Defenders no longer exists, but one can see the old hate and prejudice that continued against English rule in the Irish Republican Army (IRA formed in 1916) and its successor the Provisional Irish Republican Army. The Orange Order still exists today as a Protestant, political movement, meeting in lodges and under a Grand Master, conferring upon its members the Orange degree and the Royal Arch Purple degree. The Royal Black organization although a separate body, confers the 'high' degrees on those that have previously received the Orange degrees, and of the age of seventeen and male. The Orangemen still parade at least once a year, sometimes taunting those on the sidelines. In recent years, many of its lodges have been subject to vandalism, but thankfully the extreme violence that arouse in the twentieth century, seems to have considerably relaxed. -----*What do you think?*

The purpose of the Lexington Scottish Rite Foundation is to treat children age 2-5 with speech and language disorders. Speech and language disorders affect approximately 6 million children in the US. Many of these childhood problems do not mean mental deficiency or emotional disturbances. Often, these children at least average or even superior intelligence through normal speech or language channels. Services are available regardless of race, religion or ability to pay.



Services are available regardless of race, religion or ability to pay. We currently have 2 Rite Care Centers (Horn, Richardson & Associates and The Lexington Hearing and Speech Center). The cost to provide therapy to

one child can cost up to \$2000 per year. The Lexington Scottish Rite Foundation treats approximately 10 kids per year.

We hold fundraisers throughout the year consisting of Country Ham Breakfast, Clay Shoot and Pancake Breakfast to support these children. We invite the children and their families we support to the Consistory for our annual Christmas dinner. Here, Santa comes and reads them a story and gives each child a gift that is supported by the Foundation.

Children are tomorrow's citizens and the hope for our world. Helping children overcome their challenges is a major contribution to our future.
